
he Federal Government is set to supply adequate power to the 40 Federal Universities and their Teaching Hospitals across the country. The Minister of State for Power,

Works and Housing, Honourable Mustapha Baba Shehuri, made this known on Monday, 19 September, 2016, at a critical stakeholders' consultation with the Honourable Minister of Education, represented

Ministry's Energising Education (EE) Programme targeted at tertiary institutions.

The Minister explained that the EE programme was conceived to work with the stakeholders to achieve the goal of incremental power supply to the tertiary education sub-sector. The aim, he added, was to find a lasting solution to the power supply challenge in the HEIs.As part of the Ministry's integral rural electrification plan, Hon. Shehuri said that the energising education programme had been designed to serve as a catalyst for rural electrification and development. He reasoned that 'with all universities evenly distributed across the six geo-political zones, the impact of the project would be felt throughout the country.

Hon. Shehuri expressed the hope that the project would provide adequate power supply for the universities through the utilisation of off-grid Independent Power Projects (IPPs) and Public Private Partnership (PPP) structures put in place by the Ministry. While reminding the participants that their input was paramount to its success, the Minister appealed to the stakeholders to work as a team to make the programme a reality.

In her remarks, Senior Special Assistant (SSA) to the President on Power, Mrs. Damilola Ogunbiyi, noted the key role that education plays in achieving the common objective of economic growth and sustainable development in the

She explained that the world. programme, would be executed through the PPP within a short time frame of 12-18 months, with the IPP utilising various energy sources such as gas and solar. She expressed hope that, with consistent power supply to these critical and historic educational institutions, their productivity and efficiency, would be significantly enhanced, with the corresponding impact on the quality of their graduates.

Stressing on the benefits of the Project, Mrs. Ogunbiyi said that it had been structured in a way to enable the IPPs to supply power to the surrounding rural communities. She added that it would promote a decentralised, multi-demographic approach to infrastructure delivery in line with the National Rural Electrification Strategy. The public sector would also benefit from the private sector investments in the project.

On the critical action plan, the

that the project would involve the installation, operation and maintenance of the power plants for a period of 10 years. During this period, there would be adequate and constant power supply to the universities' central power house, which would in turn provide work experience for their students. Government would also

ensure that the IPP construction team complied with environmental safety standards and the terms of the embedded generation license.

Based on the requirements and need for success, the Presidential Aide said that energy demands study would be carried out for a minimum of 24 hours on each campus. According to her, the exercise would be jointly undertaken by competent staff of the universities with the team tasked with conducting the energy demand study to ensure continuous power supply for the duration of the study. Other vital issues raised include, the need for regular supply of diesel to power the generators within the period, to allow the energy audit team access to various distribution entry points, adequate land site and relevant documents.

At the end of the interaction, stakeholders agreed on need for effective partnership among the collaborating sectors.

The Executive Secretary of NUC was represented by the Director, Information and Public Relations, Ibrahim Usman Yakasai.

# 'Be Patient With Govt.' Prof. Rasheed **Urges NASU**

The Executive Secretary, National Universities Commission (NUC), Professor Abubakar Adamu Rasheed, mni, MFR, has appealed to the Non-Academic Staff Union of Educational and Associated Institutions (NASU), to be patient with the Federal Government as it is trying to address the challenges of the Education |Sector. He gave the advice on Monday, 19 September, 2016, at the opening ceremony of the 2016 National Executive Council (NEC) meeting of the Union held at Ayalla Hotel, Abuja. He said, "it is my sincere appeal that you exercise more patience to allow the present administration of President Muhammadu Buhari, GCFR, to conclude its development plan for the Education Sector, which would

definitely impact positively on the lives of all Nigerian workers."

The Executive Secretary urged the group to imbibe the culture of peace, harmony, constructive criticism and conflict resolution to avoid incessant disruption of the academic calendar of Nigerian higher institutions. This, he said, could be achieved only by maintaining the tradition of constant consultation with relevant regulatory agencies and seeking clarification on matters, whenever in doubt. He recalled that as a former Vice-Chancellor of Bayero University, Kano, he was involved in resolving industrial disputes arising from the on-going implementation of the agreements signed by the Federal Government and university-based unions.

Professor Rasheed observed that


although, some aspects of the 2009 agreement were currently facing some challenges of implementation, he has, since assuming office as Executive Secretary of the Commission, been engaged in several meaningful consultations with the Honourable Minister of Education, relevant Government Ministries and Agencies as well as other stakeholders in the system, including the university unions, on how to ensure speedy resolutions of all outstanding issues in the 2009 agreements.

Earlier, in a welcome address, President of the Union, Comrade Chris Ani, expressed appreciation to the Executive Secretary and other heads of institutions and agencies where NASU has branches, for honouring the invitation. He assured them of the union's determination to partner with government in actualising the institutions' set objectives.

Comrade Ani called on Federal and State Governments to implement the various agreements reached with the Union such as the issues of short fall in personnel emolument of tertiary institutions, university staff schools, payment of CONTISS 15 migration to staff of Polytechnics and Colleges of Education, implementation of 65 years retirement age for NASU members, among others, to ensure industrial harmony. He called on

State Governors, who were yet to pay staff salaries, to do so, in order to cushion the effect of the economic recession. He also advised them to curtail excessive travels and prioritise state expenditure to ensure judicious utilisation of state funds. He called on the Federal Government to hold State Governors

accountable for bailout funds given to them.

The President expressed worry over the proposed introduction of Communication Tax, as it would further increase the burden of Nigerian workers.

# UniAbuja Must be Pride of City, Nation -Prof. Rasheed

t is in the interest of all ■ Nigerians to have a functional University of Abuja (UniAbuja) that befits the beautiful capital city, the Executive Secretary, National Universities Commission (NUC), Professor Abubakar Adamu Rasheed, mni, MFR, has said. He made the observation when he received the Vice Chancellor, Professor Michael Adikwu and members of his Management Team in his office, on Wednesday, 21 September, 2016.

Professor Rasheed expressed regret that, in many respects, especially the state of its facilities and infrastructure, UniAbuja was far from being the Pride of Abuja. He, therefore, tasked the Management to make the development of the University, in all its ramifications, its key interest. Recalling how former principal officers and staff unions

of the Institution worked at cross purposes in the past, the Executive Secretary commended the observed team spirit between the Vice Chancellor and his team, urging them to keep it up because, he said, "you cannot build a university when you do not have a common goal."

Professor Adikwu said his team was at the NUC to congratulate the Executive Secretary on his appointment and also present some challenges facing UniAbuja to the Commission. These include the pending accreditation of a number of its programmes, shortfall in staff emoluments, which had hampered the full payment of staff salaries; inadequate funding that led to a large number of abandoned projects and also affected the development of the Distance Learning Centre as well as encroachment on the University's land.

Dwelling further on the challenges, the Vice Chancellor said, with the staff being paid about 84 per cent of their salaries, the University was unable to recruit more staff, to improve the quality of its programmes and satisfy one of the key accreditation requirements. He disclosed that no fewer than 13 Second Class Chiefs, a Secondary School, Police Station and Health Centre, among others, are currently on the University's 12, 000 hectares of land. He therefore appealed to the FCT Minister, Minister of Education and NUC to come to its aid as the University could not control the encroachers.

In his response, Professor Rasheed explained that accreditation of programmes was now a system-wide activity to be undertaken by NUC, only in May and November of every year. He



advised the University to set up an internal quality assurance mechanism, prepare some of its programmes for the November 2016 exercise and some others for May, next year. He also tasked the Management to articulate a very clear and unambiguous position paper on all the challenges

presented and come up with viable options of how to address them. This would be presented to the Commission, for onward transmission to the Honourable Minister of Education.

# Prof. Rasheed Host NUGA Executives

delegation from the Nigerian Universities Games Association (NUGA), led by the President, Professor Stephen Hamafyelto, paid a courtesy call on the Executive Secretary, National Universities Commission (NUC), Professor Abubakar Adamu Rasheed, mni, MFR, in his office, on Thursday, 22 September, 2016.

In his remarks, the President intimated the Executive Secretary that the Association came to solicit for support from the



Federal Government, through the NUC, to consider its proposal for a one-line budget to be allocated to NUGA sporting activities. This, he said, had become expedient with the poor performances recorded by Nigerian athletes at many sporting events, including the recent Olympic Games, where the country's contingent could barely scratch out a Bronze medal from the football event, describing it as unimpressive. He noted that NUGA was conceived as a veritable avenue for discovering talents that had represented the country in the times past and to also check youth restiveness and divert their minds from social vices on the campuses.

Professor Hamafyelto told the Executive Secretary that despite its modest achievements, NUGA had never being captured in He stressed that Budget, Government needed to assist the Games Committee to ensure that the objectives of raising athletes for the country is met. He decried the fact that students had to pay their way to competitions within

and outside the country and requested the Commission to prevail on the Federal Government to address the matter.

The NUGA President also informed the NUC Scribe that Federal University of Agriculture, Markurdi, was given the rights to host the Games. The institution had however postponed the Games due to its inability to complete the sporting facilities and hostel accommodation for the athletes.

Responding, the Executive Secretary thanked the team for according the Commission such honour of conferring with it on a matter that affects students of the Nigerian University System (NUS). He expressed regrets that as a result of postponement of the Games, students are denied the opportunity to participate after long period of preparation. The postponement also disrupts the university academic calendar. He, therefore, advised the visitors to initiate a process that would allow universities bid for the hosting rights, and thereafter encourage them through regular visits to

inspect their facilities and level of preparedness to host the Games.

On the request for support by the Federal Government, the Executive Secretary promised to open up discussions with Honourable Minister of Education to consider ways of assisting the Games.

The NUGA President thanked the Executive Secretary for the advice, promising that the Committee would deliberate on it at the Council level.

In the delegation were the Chairman Technical Committee, Nick Igbokwe; Ist Vice-President, Emeka C. Ogbu; Secretary-General, Bola Orodele; Treasurer, Professor M.G. # NATIONAL UNIVERSITIES COMMISSION IPSAS IMPLEMENTATION



#### Intoduction:

The Federal Executives Council at its meeting held on 28th July 2010 approved that Nigeria should adopt the provisions of the International Financial Reporting Standards (IFRS) and International Public Sector Accounting Standards (IPSAS) for Private and Public Sectors respectively.

Consequently, the Federation Accounts Standards Allocation Committee (FAAC) at its meeting held on 13th June 2011 setup a Sub-Committee to provide a roadmap for the implementation of IPSAS in the three tiers of government in NIgeria.

#### The Roadmap to the adoption of IPSAS was phased as follows:

- Full Adoption of IPSAS Cash effective from1st January, 2014.
- Adoption of IPSAS Accrual effective from 1st January 2016.

The National Universities Commission (NUC) has commenced the IPSAS implementation project that will enable a seamless adoption of the IPSAS accrual in the preparation and presentation of Financial Statements in line with the directives of Federation Accounts Allocation Committee (FAAC) Sub-Committee on implementation of IPSAS.

#### Implementation Approach:

NUC is partnering with Nexia Agbo Abel & Co, to adopt a phased implementation approach which shall focus on the following areas:

- Regulatory Compliance
- Technical Accounting & Reporting
- Knowledge & Resource Management
- Process, Technology & Infrastructure

#### IMPLEMENTING STEPS FOR NEW MEDICAL SCHOOLS, ACCREDITATION ISSUES AND THE NEW MINIMUM BENCHMARK (2015) FOR THE MBBS/BDS PROGRAMMES

#### **PROGRAMMES**

Following several Stakeholders' meetings in the last two years and as a prelude to the formal release of the New Minimum Academic Benchmark (2015), proprietors of Medical and Dental Schools in Nigeria (both current and prospective) are requested to note the following implementing steps including relevant adjustments relating to accreditation of Medical/Dental Schools.

- 1. From 1st September 2015, both current and prospective proprietors of Medical and Dental Schools should:
- Write a letter to the Executive Secretary stating their intent and provide relevant information as available. a.
- On receipt, (if NUC has no obvious reasons to disqualify the application), they would be sent a copy of the BMAS for b. MBBS/BDS and advised firmly to ensure that they are strictly complied with.
- The setting up of medical schools is not an emergency exercise. To this end, prospective proprietors must own and c. have in place (prior to a request for a Resource Verification), a fully functional and well run tertiary type hospital. In the circumstance of the above not being in place, consideration for an affiliation with a tertiary government-owned institution may be given only when the said university owns a medical institution fully functional with a minimum of 150 beds and a rural health medical unit. (See Appendix 4 of the BMAS).
- A Pre-clinical Accreditation would be expected to take place within two years of a positive Resource Verification. d. Students can only sit for the second MBBS professional examination (Anatomy, Physiology and Biochemistry) when they have a successful preclinical accreditation. The preclinical accreditation would, amongst others, concentrate largely on the Department of Anatomy, Biochemistry, Physiology, Pathology and Pharmacology and to a lesser extent, Community Health. All evaluated departments must have the minimum requirements in terms of academic staff, non academic staff and laboratory facilities. (See Appendix 3 of the BMAS)
- The Commission has now approved a Clinical Accreditation expected to take place within twelve months of a e. successful preclinical accreditation. Subsequent to that, a reaccreditation exercise will take place every five years.
- 2. With respect to established medical schools, (and irrespective of their accreditation status), it should be noted that





only institutions that (by the deadline of March 20th, 2016) have requested and obtained formal approval from the National Universities Commission for a re-evaluation based on the following considerations would be allowed to admit students into the MBBS/BDS programmes from the 2016/2017 academic year:

- All Medical and Dental schools must have an approved, and appropriately utilized, Clinical Skills/Simulation centre. a.
- b. Ensure strict adherence to the proper use of the course system for all approved programmes in Nigerian Universities. The implication of the above is that a particular programme (subject) is taught not only broken into cluster units of 1-4 but also have the components of university supervised examinations. For clarity, current end of posting examinations (practiced by some medical/dental schools) that neither have units allocated nor follow the standards of a University examination, do not conform to the Minimum Academic Standards as established by the National Universities Commission.
- Universities are strongly urged to immediately review their current methods of teaching medical and dental students c. to include more tutorials, self study group teaching, use of IT in the delivery of courses and simulation/competency based evaluations that must be signed by a lecturer not below the status of a senior lecturer. It must be noted that the confirmation of a successful simulation/competency based evaluation should be a mandatory requirement before the students are eligible to sit for the various professional/sessional examinations
- Proprietors are urged to note the Essential Component changes of the new curriculum expected to be in use from the 3. 2016/2017 academic session. Details of these changes are available in the New Minimum Academic standards booklet and at the National Universities Commission website. (www.nuc.edu.ng.) Major components include the following:
- (a) The approval of three alternative models viz;
- i. A seven year MBBS/BDS programme that encompass a mandatory seamless four-year acquisition of the B.Sc. (Basic Medical Science) with interest in either Anatomy/Physiology/Biochemistry. At the end of seven years, students would have acquired the Bachelor of Basic Medical Science, Bachelor of Medicine and Bachelor of Surgery degrees. In case of the dental programmes, the students would have acquired a degree in Basic Dental Science and Bachelor of Dental Surgery.
- In order to allow for career change for interested non-medical health professionals, the Commission has also ii. approved a four year programme leading to MBBS/BDS for interested and qualified graduates of Nursing, Pharmacology, Physiotherapy, Image Science, Paramedics, Anatomy, Physiology, Biochemistry and Pharmacology. It must be noted for such to be considered for admission they must have at the WAEC/NECO levels minimum credit scores in Mathematics, English, Physics, Chemistry and Biology at one sitting, prior to the admissions for their first degrees. They must also have a good CGPA.
- Admission into universities based on the current six year programme would be allowed to continue as suitable iii. alternative based on the discretion of the University.
- It should be noted and emphasized that all the above degrees have the Bachelor appellation as they remain iv. undergraduate programmes.
- Specific periods of posting to the department of Family Medicine. The obvious implication here is that, the (b) Universities should create the Department of Family Medicine following their due process.
- Redesignation of the Department of Pharmacology to the Department of Pharmacology and Therapeutics. The (c) department is now expected to provide relevant basic clinical teaching and conduct relevant professional examination in Pharmacology. They will also be expected to provide relevant clinical teaching in Therapeutics. All Universities should set in motion the machinery to achieve the above.
- 4. In view of the above essential component changes of the new curriculum, the Commission will be organising a National training for Medical teachers in Nigerian Universities. Details of the training would be made available shortly.

he National Universities Commission, cognizant of the need to streamline the operations of Part Time and Sandwich programmes in Nigerian universities, had through a publication in the print media, including the Guardian and Sun Newspapers of Monday, 19th March, 2012, placed a moratorium on admission into parttime programmes in Nigerian universities. In the publication, the universities were requested to fully disclose all Part-Time and Sandwich programmes, with respect to enrolment and staffing profile, within four weeks of the publication, and to conduct in-house staff and student audit and forward same to the Commission. As a follow up to this, the Commission vide a letter dated 14 January, 2013, sent a reminder to the universities requesting those that were yet to provide information on their Part-Time and Sandwich programmes as well as affiliation arrangements to do so on or before 15 February, 2013.

#### GUIDELINES ON PART-TIME AND SANDWICH PROGRAMMES IN NIGERIAN UNIVERSITIES

Below are guidelines for conducting Part-time and Sandwich programmes in Nigerian universities. All universities currently operating Part-time programmes are expected to comply with the guidelines on programme by programme basis.

Consequently, universities still interested in running Part-time programmes are advised to forward fresh applications to the NUC on programme by programme basis.

This is, however, subject to the readiness of the university to comply with the following extant guidelines on part-time programmes:

- The admission and graduation requirements, Staffing, Library and physical facilities requirements must be in line with the Benchmark Minimum Academic Standards (BMAS) for the various full-time academic programmes;
- 2. For a programme to be eligible to run on part-time basis, the approved full-time equivalent must be available in the university, must have earned full accreditation and must be run within approved campuses;
- 3. The enrolment into part-time programmes must not exceed 20% of total students' population in the programme;
- The minimum duration of the part-time programmes must be 150% of the approved duration of the Full-Time equivalent;
- Approval shall not be granted for part-time programmes in Environmental Sciences, Engineering/Technology, Law, Medicine/Medical Sciences, Pharmacy /Pharmaceutical Sciences, Dentistry; and Veterinary Science;
- 6. All admissions into part-time programmes must be through the Joint Admissions and Matriculation Board (JAMB). Part-time programmes must be run within approved campuses of universities where the human and material resources for the teaching of the programmes are domiciled, i.e. on the main campus of the university;
- 7. Part-time programmes shall be subjected to the NUC accreditation assessment upon maturity of the programme;
- For any programme to be eligible for part-time mode, it must have produced two (2) sets of graduates and satisfied the Resource Verification Requirements.
- Commencement of a part-time programme MUST be subject to NUC's approval. Approval of commencement of all parttime programmes must be obtained.

The National Universities Commission shall not hesitate to apply appropriate sanctions on any university which violates any of the stipulated Guidelines on Part-Time and Sandwich Programmes.


