

Unimaid @ 40; Intensify Research to Halt **Shrinking Lake Chad**

- President Buhari at Convocation.

he Visitor to the University of Maiduguri (Unimaid) and President Federal Republic of Nigeria, Muhammadu Buhari, GCFR has charged the University which held its 22nd combined convocation and 40th Anniversary celebrations last Saturday April 16th, 2016 to intensify research into positive ways of dealing with the consequences of shrinking of the Lake Chad Basin and its associated aquifers.

In the Visitor's address at the convocation ceremony, read by his representative, the Executive Secretary of National Universities Commission (NUC), Professor Julius A. Okojie, OON, the President said that, although, part of the Lake Chad Basin was strategically located in Borno State, its current state of decline was of utmost concern to member Countries of the Lake Chad Basin

Commission (LCBC), which Central African Republic. comprised Nigeria, Chad, Cameroon, Niger and Algeria. According to Mr. President, Other member Countries are Liberia, Congo, Sudan and the

Statistics and satellite imaging had shown that the lake had receded to

less than 20 percent of its original size. "Since 1963, the surface area of lake Chad has decreased from approximately 25,000 square kilometers to 1,500 square kilometers". He identified desertification, wrong irrigation, damming practices and climate change as mostly blamed for the problem, adding that many people were dependent on the disappearing waters and forest resources and that the age-old fishing tradition of the surrounding regions had all but disappeared, thus food supply, livelihoods and indeed the security of Millions of people are threatened.

The Visitor said research had shown that clear correlations between poor nutrition, poverty, ill-health, and insecurity of lives and property were due in part to high competition for scarce resources and that Nigeria could not afford more unrest especially in the face of insurgency and other threats to lives and economy. He further tasked the University to show great interest through relevant research in the Nigeria's search for oil in the Chad Basin. maintaining that "regardless of the

declines in oil revenues, we must sustain the efforts in prospecting for oil especially in the Chad Basin.

The President advised the University to take advantages of its geographical location in the heartland of the Kanem Borno empire which existed in modern Nigeria and Chad and at its peak encompassed an area covering Chad, Southern Libya, Eastern Niger and Northern


Cameroon, by building cooperation with Nigeria's

neighbours and advancing in practical terms true brotherhood and sisterhood. "the primary beneficiary of the vision of cooperation with these Countries would be Maiduguri, hence the need for the University of Maiduguri to make itself highly relevant and central to its immediate environment".


He gave some of the key areas where these collaborations were

required to include National security and diversification of the economy and maintained that these were his administration's top priority following the activities of insurgents and steep declines in crude oil revenues.

President Buhari particularly commended the resilience of the Borno State Government and all States of the North East geographical zone and their people as well as the Universities, particularly the University of Maiduguri in coping with daily life and continuing academic activities in the face of very serious security threats. "My administration

appreciates and commends the Council, Management, Staff and Students of the University of Maiduguri for sustaining the momentum during a very trying period.

He noted the efforts of the State governments and the Universities, especially the University of Maiduguri in the zone towards the rehabilitation of those displaced by the insurgency and said that the Federal Government would encourage the University to lead in research to unravel the genesis of the insurgency and advance

practical solutions to the problem and ''develop academic programmes around these challenges"

Speaking on the innovations in the Nigerian University System (NUS).President Buhari said that the Federal Government had over the years tried severally to leverage technology to assistteaching, learning and research activities in Universities, adding that the efforts were now being enhanced through the Nigerian Research and Education Network (NgREN), domiciled at

the National Universities Commission Secretariat, which currently provides some Universities with the capacity for virtual literature, collaboration and exchange of information with their counterparts in Nigeria and all over the world. He said that the NgREN also provided dedicated leased lines between these institutions, internet bandwidth, IP telephony platform, video conferencing, service, repositories set-up, BGP peering, E-journals and e-books, network security services and many other additional service, like domain name services and hosting of websites. "consequently the NUC has recommended that these facilities be provided in the University of Maiduguri ATBU, Bauchi provided in the first distance".

Congratulating the University on its 40th anniversary, President Buhari noted that the University had been blessed with many intellectual giants and paid tributes to some of the pioneer Staff of the University including, Umaru Shehu, distinguished Professor of Medicine and one time Vice

Chancellor of the University of Nigeria, Nsukka, Jibril Aminu, distinguished Professor of cardiology, Diplomat and former Minister of Petroleum and former Executive Secretary of NUC, who also served as VC, UniMaid, in its early days.

Earlier on Friday, the President formally installed the new Chancellor of the University, His Imperial Majesty, Oba (Dr.) Lamidi Olayiwola Adeyemi 111, JP, CFR, LLD, the Alafin of Oyo as the 5th Chancellor of the University of Maiduguri and said that coming from a dynasty of visionary leaders of the ancient Oyo empire, it was his conviction that his experience and that of his forefathers would served him well in ensuring that the University of Maiduguri attained enviable heights. The Visitor later commissioned a new hostel block built from the University's Internally Generated Revenue (IGR). He also congratulated the Honorary Degree recipients.

The Vice Chancellor, in his address, explained that as a result of the remarkable improvement in

the security situation in the state that the University was holding its 22nd Combined Convocation. He said: "It is gratifying to note that the University will be graduating five sets of students for the 2009/2010, 2010/2011, 2012/2013, 2013/2014, 2014/2015 academic sessions, from 12 Colleges and Faculties; Distance Learning Centre (DLC) and 23 Affiliate Colleges. The summary showed that 3,623 students graduated from the School of Postgraduate Studies,

out of which 192 received Doctorate Degree; 1,498 Master's and 2,133 Postgraduate Diplomas. In the undergraduate category, a total of 37,259 students received various degrees. Out of this number, 32,869 were regular students, 841 from Affiliate Colleges and 3,549 from its Distance Learning Programme. Also, 172 graduands obtained First Class Degrees. 362 received certificates while 6,926 received Diplomas from the Consultancy Services of the University. He revealed that a total of 101,541

graduates had passed through the University since its establishment 40 years ago.

Professor Ibrahim A. Njodi said that Honorary Degrees were conferred on three eminent persons namely late General Murtala Mohammed, former Head of State, Federal Republic of Nigeria, who was conferred with a posthumous Doctor of Laws (Honoris Causa), Professor Russell G. Schuh, a renowned Linguist from the University of California, Los Angelos (UCLA), Doctor of Letters (Honoris Causa) and Mai Martaba Muhammadu Sanusi, 11. Emir of Kano, Doctor of Science (Honoris Causa). He said that the decision of the University Senate to confer the eminent personalities the honorary degrees was in recognition of their intellectual excellence, leadership qualities, exemplary character, and enduring contribution to national and international development and acclaimed commitment to improving quality of life in the society.

The Vice Chancellor also said that within the period under review, the University established new centers, linkages and outreach initiatives, in addition to the establishment of a Campus Radio and the organisation of an International Conference on the Boko Haram insurgency. He thanked the Executive Secretary of NUC for the Commission's waiver of N40 Million (Forty Million Naira) annual subscription fees of the University to the NgREN platform.

The host Governor, His Excellency, Kashim Shetima, congratulated the Management, staff and students for standing firm despite all odds and for refusing to be intimidated throughout the years of Insurgency. He thanked the University for the opportunities offered him to become an Agriceconomist, a Banker, a Politician, a Governor and also for giving him a wife. He said that the Convocation was a sign that Borno was not all about Boko Haram and Insurgency. He felicitated with the University, extending the support of the people and Government of the State and pledged to construct a network of roads in the Campus worth about N250 Million.

Niger State Governor, Barr. Abubakar Sani Bello, himself an Alumnus, said that education particularly at tertiary level was pivotal to the economic development of any country. He said that the Convocation was a mark of the University's contribution to national development and urged the students to bring to bear the problem-solving skills they acquired in their various fields of endeavors.

The Chancellor, His Imperial Majesty, Oba Dr. Lamidi O. Adeyemi, Ill, the Alafin of Oyo, explained that since inception, UniMaid had built a reputation for itself as one of the most peaceful University in the country. He noted that despite the insurgency in the North East, the University had remained opened and working towards meeting the objectives for which it was set up. He congratulated the Vice Chancellor and his Management for rising to the challenges confronting the University and for taking bold initiatives, even in the face of limited resources to sustain its operations, thereby ensuring quality and standards. He charged the graduands be worthy Ambassadors of the University.

Responding on behalf of the honorary degree recipients, the Emir of Kano, Sanusi Lamido, Il, commended the people of Borno for refusing to be defeated by the Boko Haram. He said that their tenancy and courage had earned them respect of the World, for conducting the business of teaching and learning even within the period of insurgency.





Professor Munzali Lists Remedies for Corruption, Bad Governance and Insurgency



The former Executive Secretary, National Universities Commission (NUC), Professor Munzali Jibril, OFR, has listed remedies for Corruption, Bad Governance and Insurgency to include the removal of immunity clause from the constitution of the Federal Republic of Nigeria through an amendment of Section 308 and Conversion of the Sagay Advisory Committee Against Corruption into a powerful Anti-Corruption Commission through an executive bill.

Delivering the 22nd Combined Convocation Lecture of the University of Maiduguri, held on Friday 15 April, 2016 with a theme Nigeria: Corruption, Bad Governance and Insecurity", Professor Munzali said that the functions of such Commission should include coordinating the fight against corruption, as well as the establishment of a strong and effective system for the detection, exposure and punishment of corruption.

The former NUC Scribe stated that the required leadership to confront and fight corruption which was lacking before had now been brought forth at the centre by the last elections. He explained that, for the Government to achieve this, there must be support from all and sundry, to bring about the desired change in attitudes, processes and procedures and to build institutions that are strong enough to withstand attempts that may be made by future dictators who might want to return the nation to the status quo ante.

Professor Munzali observed that, on the political front, the Nigerian people had taken an important step towards ensuring that henceforth elections are free, fair, credible and acceptable, adding that there was need for improvement on the achievements recorded by Professor Attahiru Jega-led INEC. He noted that one of the fall outs of that election ought to be the restoration of internal democracy within political parties and the elimination of god-fatherism and the misuse of incumbency to cling to power.

On the nation's economy, Professor Munzali advised that there was need for the Federal Government to either ban imports of goods which the country could produce or tax them so highly that it won't make economic sense for any consumer who earns his money legitimately to buy them, adding that the Government should take all measures to protect its local textile and other industries against cheap Chinese and other imports and smuggled goods. "We must also diversify our economy away from dependence on a single **Pg.** 8 18th April, 2016



commodity, oil. We should develop our human capital, the solid minerals sector and the manufacturing and services sectors. We must build and rebuild infrastructure such as roads, railway lines, power plants as no development can take place without an efficient infrastructure," he added.

The Convocation lecturer called on the Governments at all levels to restore accountability in the polity,

smoke out impunity and banish it from the land, stressing that the role of the Civil Service as the custodian of government property and the protector of public funds and other resources against vampire political office holders must also be restored. He added that the Government should maintain a balanced ration of 60:40 within the recurrent budget between personnel emoluments and overhead so as to ensure that employees do have the tools and

materials that would aid them discharge their duties in order to justify their pay.

Professor Munzali further advised that the legislators should revert to part-time status and that this should be reflected in their remuneration packages. He stated that the national budget should be restructured so that 75% of it is spent on capital expenditure while only 25% is spent on recurrent expenditure, saying that this was, however, possible as the immediate past Governor of Kano State, Engr. Rabiu Musa Kwankwaso was able to achieve the same feat in 2013 and 2014 and without having a deficit or borrowing a kobo to finance the budget.

The former NUC Scribe also called for the removal of the police, EFCC, ICPC and the Public Prosecutor' Office from the control of the executive branch and conferring on them operational autonomy with accountability to a re-invigorated National Assembly. He said that


Government should ensure that corruption became a risky and unprofitable business by making the probability of detention and punishment high. He called for aggressive and well-coordinated poverty reduction, employment creation and wealth -creation policies which would create more national wealth through higher productivity and re-distribute it so that the inequality gulf could be considerably in narrowed.

The Convocation lecturer called for repatriation of Nigerian looted funds from foreign countries (estimated to be in the region of \$100 billion) which should be used to improve infrastructure nationally and also create employment for the citizenry. He added that the repatriation of the funds should be preceded by a thorough but discreet investigation into what each government official had in his or her foreign account, how they acquired it, among other things, after which they would be confronted with the evidence and be given the choice to surrender the money quietly, in return for protection from public exposure, or risk a full-scale prosecution in the courts.

He called for enforcement of sanctions against those found guilty of corruption, which should include the seizure of their loot and appropriate additional

punishment, such as imprisonment.

Professor Munzali also called for further deregulation, reform and transparent privatisation of key sectors of the economy in order to reduce opportunities for public sector corruption. He said that "President Buhari has his job cut out for him in the next three years, and that is, to carry out farreaching reforms such as those outlined above, to put Nigeria back on track towards rapid socioeconomic and infrastructural development. Even if this is all he achieves in four years that would earn him a place of pride among builders of modern Nigeria".

Eastern Palm Varsity Receives Certificate of Recognition

he Eastern Palm University, Ogboko, Imo State, has been issued a certificate of recognition by the National Universities Commission (NUC), as the 42nd State University and 143rd University in Nigeria. Presenting the Certificate to the Governor of Imo State, His Excellency, Chief Rochas Okorocha, on Wednesday, 13 April, 2016, the Executive Secretary of NUC, Professor Julius A Okojie, OON, called for a Marshall Plan for the Nigeria Education System in search of a holistic solution to the challenges of the education sector as it was an important sector upon which the development of the country depended.

The Executive Secretary argued that Nigerian graduates and the Nigerian academics were globally competitive, as demonstrated by the scholars of the Presidential Special Scholarship for Innovation and Development (PRESSID) and the 10 Nigerian Universities that emerged as Africa Centres of Excellence (ACEs) out of the 22 African Centres, from the West and Central African regions. He maintained that Nigerian graduates were employable, that they had prospects and that job experience was acquired over time.

He said that quality education did not come cheap as people had to pay to acquire it. In his words "If you want good education, you pay for it; if the Government says it is providing free education, it must make money available to universities." He submitted that it was unpatriotic for Nigerians to berate graduates from the system as unemployable.

Professor Okojie advised the new university to run programmes that are relevant to its immediate environment as universities had the responsibility of meeting local and national needs. He enjoined the University to start small and to stick to the take-off Faculties so as to enable it grow gradually, noting that the first 10 years of any university could be very precarious. Governor to ensure that the University's Principal Officers are men and women of integrity who would nurture the University and to also follow due process in their appointment. He advised him to pay regular visits to the Institution to monitor its progress. The NUC Scribe observed that in developed countries, major facilities were donated by industries to universities to aid research. He gave the example of Toyota, which provided 200 vehicles to a community college in Arizona, USA for practicals. He, therefore, advocated the creation of an enabling environment in the country for industries to thrive as that would promote synergy between academic institutions and the industrial sector.

Responding to Governor Okorocha's observation that Nigeria had no Ivy League institution, the Executive Secretary said that the Ivy League universities in the United States of America, evolved overtime and had stuck to their traditions. He explained that the parameters used in ranking universities in the world favoured institutions in the

developed countries as they had matured over time, with some founded more than 500 years ago. He explained that before a second university was approved for any State with an existing one, such a State must show evidence of adequate funding of the existing one. This has become a precondition for obtaining approval from NUC.

He observed that access to education was still a challenge and that State universities were the most challenged due to quick political succession and undue

interference from the Governors. He warned that as a penalty, the Commission would not visit any university without a proper governance structure.

Receiving the Letter of Recognition, Governor Okorocha said that the Imo State House of Assembly had also given a legal backing to the University. He disclosed that the plan to establish the University started about 12 years ago, first as Rochas Foundation University, but then later as Eastern Palm University, in order to meet the educational needs of the State. He revealed that the State recorded the highest number of applications in the 2016 Universities Tertiary Matriculation Examination (UTME), underscoring the need for more universities in the State. He called for the classification of universities in the country, saying that universities should be known for specific areas of specialisation.

Governor Rochas commended the efforts of the Executive Secretary and the NUC at repositioning the Nigerian University System

(NUS). He described Professor Okojie's welcome address as "thought-provoking" and submitted that it would be necessary for the Executive Secretary to address a meeting of the Nigerian Governors' Forum in order to share his thoughts on how best to run the system. He called for the establishment of more specialised universities that would address the basic needs of

the people.

The Governor expressed displeasure that whereas Nigerian public universities demanded autonomy they continued to rely on Government for funding. He noted that Government alone could not bear the cost of education, considering the economic down-turn. therefore, called on the universities to be more innovative

in generating funds to run their affairs. He added that the new University planned to be among the best in Nigeria.

In the Governor's team were the Vice-Chancellor of the new University, Professor Chima Iwuchukwu, some members of the Federal House of Representatives, including Hon. Chike Okafor and Hon. Austin Chukwuma. Others were Barr. Teddy Akwari, Hon.

Minister Directs Varsities to Connect to NgREN

... Commends NUC for Leadership in Resource Sharing

The Honourable Minister of Education, Malam Adamu Adamu, has directed tertiary institutions in Nigeria, especially the federal universities, to avail themselves of the opportunities offered by the Nigerian Research and Education Network (NgREN) and connect to the platform.

Declaring open a One-Day Workshop on EBSCOHOST Electronc Content, organised by the National Universities Commission (NUC), in collaboration with EBSCO, South Africa, held at the Idris Abdulkadir Auditorium, NUC, Abuja, on Tuesday, 12 April, 2016, the Minister stated that the Federal Government would no longer condone a situation whereby institutions collect money and individually incur

higher costs when a cheaper alternative was available, through consortium and economies of large scale, provided by the

NgREN. The Workshop, facilitated by the NgREN, is aimed at sensitising Nigerian universities on access and usage of e-Book Academic Collection.

The Minister, represented by the Honourable Minister of State, Professor Anthony Anwukah, expressed delight that the NUC was leading the way in supporting the Nigerian University System (NUS) towards becoming a worldclass system, not only in facilities and teachers, but also in information resources. He stressed that, with the revealing experience of what the NgREN could do when he visited the Commission on 1 March, 2016, there was no reason for universities to independently pay for services like bandwidth or electronic journals subscriptions when those services are available

on the platform. He, therefore, charged the Commission to commence the process of identification of other sources of information and facilitate availability to the NUS.

In striving to achieve this, the HME said that the Federal Government was aware of the challenges of funding and other resources, advising the NUC to work closely with key agencies such as the Tertiary Education Trust Fund (TETFund) to ensure the sustenance of an excellent information base for Nigerian tertiary institutions. He added that the NUC should explore partnerships with other agencies, promising that, where necessary, the Ministry would readily support it in the implementation of such partnerships. He expressed satisfaction that another value was being added to the NgREN, with the provision of electronic books and journals, using EBSCOhost, which would offer additional access to researchers.

While urging the nation's universities to continue to take advantage of facilities at their disposal and to make appropriate use of such to enhance quality, Malam Adamu called on them to imbibe the principles of fiscal responsibility and value for money, by keying into the success stories recorded with the NgREN. He identified the NUS as a critical component in the Buhariadministration's determination to leave a legacy of highly skilled manpower that could support social and economic development of the nation.

In his welcome remarks, the Executive Secretary of NUC, Professor Julius A. Okojie, observed that there three resource persons from EBSCO were invited to train the participants,

but that they could not physically make it due to the challenges of visa procurement. He, however, expressed delight that the NgREN platform was able to tackle the same issue by allowing the speakers to interact with the participants, through videoconferencing. He noted that the present stage of the NgREN provided opportunities for endusers to have access to e-Books, e-Journals, video and teleconferencing, stressing that universities needed to subscribe to the network to enable them eniov cheap bandwidths as the present situation whereby they subscribed individually to private providers was unduly expensive.

Professor Okojie recalled that between 2001 and 2005, Nigerian universities with the support of the Open Society Initiative had access to EBSCO resources, which expired and got revived at a point, with support from TETFund and lasted until 2009/2010, when there was no further subscription. He expressed the hope that with EBSCO giving a trial access to the NUC, which was currently available on the NgREN, the good days had returned to the NUS, especially with the agreement with EBSCO to allow the universities have a six-month free

trial to full texts of e-Books and e-Journals.

The Executive Secretary stated that the NgREN was a key driver in the transformation of information and its availability in the universities, adding that with the central role of libraries in education and innovation, it offered opportunities for them to be in a better position to generate, organise and disseminate relevant information to their communities. He listed the objectives of the Workshop, among others, as including: the sensitisation and training of participants on the use of the EBSCO eBook Academic Collection and alert the universities on the advantages and features of the platform, include the new EBSCO discovery service. He said that one of the advantages of EBSCO eBook and e-Journals was the fact that the resources were current and cheap to reprint through the platform.

In a goodwill message, the Chairman, Senate Committee on Tertiary Education and TETFund, Sen. Binta Masi Garba, remarked that the NgREN, with its

potentials, would serve as a middleman between EBSCO resources and the universities. She enjoined the institutions to make adequate use of the resources for research purposes. While expressing satisfaction that the elearning resources were being upgraded in her time as Chairman of the Committee, Senator Garba said that her desire was to see that capital flight currently experienced in the country was reversed, with the repositioning of education.

In a vote of thanks, the NUC Project Coordinator, Dr. Joshua

Education as well as the Executive Secretary and his Management team for their support, stressing that NgREN was expected to provide a platform for an excellent collaboration that would enhance the use of world-class resources for teaching and learning in the NUS.

In an online presentation, on "eBooks-What EBSCO has to offer and Considerations for Universities", the Vice-President, Colleen Mills, said that EBSCO had its presence in Nigeria since the year 2000, but that due to changes in the environment. Nigerian universities had not been able to maintain their subscriptions to the platform. She noted that the stakeholders would receive information on the web content available in EBSCOhost, the way it worked as well as the new technology at the site.

The EBSCO Vice-President stated that the platform could provide access to eBooks and Journals, including animated pictures that stimulated research and were hugely available to anyone, anywhere. "It also makes

CIPMN Seeks Review of Human Resource Progs.

he Chartered Institute of Personnel Management of Nigeria (CIPMN), on Wednesday, 13 April, 2016, solicited for a review of Human Resource programme for students of universities in the country to enable them undertake the academic and professional training courses simultaneously and earn dual certification upon graduation. The institute also requested for partnership in the areas of accreditation of the programmes and regulation of Human Resource practice for university academics willing to engage in professional practice. The Acting Registrar and CEO and Director, Professional Development of CIPMN, Dr. Charles Ugwu, made these statements when he led a delegation on a courtesy call on the Executive Secretary, National Universities Commission (NUC), Professor Julius A. Okojie, OON, in his office.

Dr. Ugwu said that CIPMN would be 50 years, by March, 2017, and was established by Act 58 of 2001,

with the mandate to define standards and regulate practice. The body, he said, had been able to increase the number of its professionals to over 2,000 and was now issuing licences to Human Resource Practitioners which ensured the holders' currency in Human Resource practice and principles. He noted that one of the Institute's strategic objectives was Advocacy, in the form of institutional collaboration, having felt the impulse of the needs of the industry, as it was seeking with the NUC, through curriculum integration of both CIPMN and the academic programmes of universities.

The Director noted that this partnership had already been opened up with Covenant University, Ota, Ogun State, through a Memorandum of Understanding (MoU), which guaranteed dual certification (academic and professional certification), with the

progessional certification helping to bridge the gap "between town and gown." He said that the Professional graduates were not only academically sound, but also readily employable and with competitive advantages over others.

Dr. Ugwu disclosed that CIPMN was also relating with the National Board for Technical Education (NBTE), to beef up the curriculum contents of the nation's polytechnics. He stressed that its incorporation would add value to the curricula of the universities, polytechnics and colleges of education, adding that the course would address all the fields and strata of activities associated with Human Resource practice.

Welcoming the delegation, Professor Okojie briefed them on the roles, functions and responsibilities of the NUC that bothered on the orderly development of university education and quality assurance in

the Nigerian University System (NUS). He explained that Act 2004, of NUC, empowered it to establish private universities and to prescribe Minimum Academic Standards for programmes to guarantee access and standards in the system.

The Executive Secretary told the delegation that NUC was open to collaboration with professional bodies such as CIPMN, which would help it achieve its mandate. He stated that the challenge with professional bodies was their proliferations and the fact that some of them had mandates that usually overlapped with those of the Commission. He acknowledged that the terms of reference for collaboration with CIPMN were well-defined. streamlined and well-intentioned and could enrich the regulatory activities of NUC. He said that this was unlike some other bodies whose activities were overbearing, and which had quality assurance challenges within their own membership.

Professor Okojie informed the professional body that the Commission was working towards ensuring that universities


took ownership of the accreditation process by engaging in self-quality assurance evaluation, such that the NUC would only perform monitoring oversight. This was the crux of his paper on the restructuring of accreditation exercises in the NUS at the Convocation Lecture of the Nnamdi Azikiwe University, Awka.

Concerning the mission of CIPMN, Professor Okojie said that the NUC was willing to partner with the institute since the whole idea was to enhance the training of quality graduates in

the universities. In its contribution, the NUC Management collectively agreed that the model of the Nursing and Midwifery Council of Nigeria and the Council of Legal Education provided a good basis for a working relationship with the CIPMN. The model guarantees that students take some of the professional courses simultaneously, as in the proposal of the CIPMN, with their academic courses and would write few other professional courses on graduation, so as to qualify to practice.

At the end of the interaction, the NUC Directors of Reaserch and Innovation, Dr. Suleiman Ramon-Yusuf, Academic Standards, Dr. Gidado Kumo and Quality Assurance, Dr. Noel Saliu, were nominated by the Management to further explore the terms of the collaboration with CIPMN.

Also in the delegation were CIPMN's Director, Membership Development, Mrs. Toyin Ojudun; Council Chairman, Abuja Branch, Barr. Aminu Ogaji, and the NUC Deputy Director, Discipline, who is a member, Mr. S.B Essien.



NUC Pledges Support for State Varsi

he Executive Secretary, National Universities Commission (NUC) Professor Julius A. Okojie, OON, has reiterated the Commission's preparedness to support State Governors in their quest to achieve qualitative tertiary education in their States. He gave the assurance at the 28th Convocation Ceremony of the Rivers State University of Science and Technology RSUST, Nkpolu, Rivers State. Professor Okokie said that the Commission would continue to support State Governments in their efforts to raise the bar in qualitative university education.

The Executive Secretary, who was represented by the former Vice-Chancellor of the University of Uyo and Visiting Professor to NUC, Akaneren Essien, called on State Governments to increase the funding of their Universities in the areas of Research and Development as these would not only improve the socio-economic fortunes of the states, but also ensure the overall development of the country. He also advised public universities in the country to maximise the opportunities provided by the Tertiary Education Trust Fund (TETFund)'s research intervention funds to carry out ground-breaking research.

Professor Okojie charged the State Universities to serve as a think-tank for Government by evolving workable strategies for economic diversification,



especially in the area of Agriculture, as an alternative to Oil. He said that the Commission would continue to play its statutory role of regulating Nigerian universities for the overall development of the country and commended the University for living up to expectation as the first University of Science and Technology in Nigeria.

In his address, the Visitor to the University and Governor of Rivers State, Chief Nyesom Wike, congratulated the University's Governing Council, Management, staff and students for their great achievements. He assured the graduands that, despite the economic challenges in the country, his administration would continue to create ample opportunities for them to be gainfully employed.

The Governor said that the development of the University was on his administration's priority list and promised to continue to support the University to achieve its mandate for the overall development of the State. In his words, "I want to assure you that we shall not fail in our commitment to support the University to maintain and grow its facilities, attract and retain quality staff and facilities, and provide a world-class educational experience for our students. We are paying and will continue to pay salaries regularly, in spite of the financial challenges the State is facing; we have approved the reconstruction of the Faculties of Management Sciences and Environmental Sciences buildings, which were abandoned. I am quite familiar with your challenges." He challenged RSUST to put the necessary facilities in place to ensure that its programmes earned full accreditation.

In his address, the Pro-Chancellor and Chairman of Council, Hon. Justice Iche N, Ndu (Rtd.) expressed gratitude to Governor Wike for his support to the University since the inauguration of the Council on Wednesday 11th November, 2015, which had distinguished him as an 'Education Friendly Governor.' He stressed that the Institution had made tremendous achievements in the short period of his administration due to the timely release of funds that

enabled it prepare adequately for the accreditation of 17 of its programmes by the NUC. He assured the State Government that appropriate steps would be taken to remedy the staffing deficiencies identified by the Commission in five of the Institution's programmes.

The Pro-Chancellor commended the distinguished Lecturer and renowned scholar, Professor Willie Okowa, for accepting to deliver the Convocation Lecture and for his enviable achievements and impact in the development of Science and Technology in Nigeria. He noted that despite the University's remarkable achievements in the time past, there was the need to review the provisions of its Statutes and Laws

No.7 of 1980, to enable it pursue the new vision of the University. Professor Okowa congratulated the graduands on their welldeserved successes saying that they had worked hard and tirelessly in the past few years to win the coveted academic trophies, during which, he said, RSUST had given them the capacity to be creative and innovative for the glory of, not only the State, but the nation as a whole.

Giving a breakdown of graduands, the Acting Vice-Chancellor, Professor Blessing Chimezie Didia, revealed that a total of 5,067 graduated in various degrees, out of which four made First Class Honours. She commended the State Governor for reinstating all the disengaged

staff of the Institution and for approving over N700 million (Seven Hundred Million Naira) to clear the accumulated remunerations for three years. She observed that the intervention of the Governor, upon assumption of office, laid to rest the protracted industrial crisis that had engulfed the Institution.



Medicine, Dentistry Programmes to Run for Seven, Not 11 Years

The new Benchmark Minimum Academic Standard (BMAS) for Medicine and Dentistry, which has since been made public by the National Universities Commission (NUC), provides for a seven-year training, leading to the award of MBBS/MDS and not the 11 years being erroneously circulated in the mass media.

Although the so called '11-year Medical Programme' stories have been credited to the Commission's Executive Secretary, Professor Julius A. Okojie's keynote address titled, 'Development of Medical Education in Nigeria: Prospects and Challenges', which was delivered at the Matriculation and Inauguration of the University of Medical Sciences, Ondo, on Saturday, March 12, 2016, nowhere in that lecture was 11 years mentioned or implied.

Prof. Okojie, who was represented by the Deputy Executive Secretary I, Professor Chiedu Mafiana, had explained that the new curriculum provides for a seamless seven-year programme. With the new curriculum, a Medical student would be expected to graduate in Basic Medical Sciences, with options in Anatomy, Medical Biochemistry and Physiology in the first four years, before proceeding for the clinical training that would run for three years.

Prof. Okojie had further explained that the reviewed BMAS went through a long process, which included wide consultations with the academia, professional associations and regulatory body, following the conduct of a Market Needs Assessment. According to him, the consensus was that medical training should be postgraduate. The main goal is to ensure that the crop of graduates emerging from the programme are psychologically matured to practice, with a high level of competency.

The new BMAS for medical education still retains the fundamental learning objectives of the six-year programme: the national development goals for health, while retaining the international outlook to guarantee global competitiveness. While noting that the extant six-year programme shall continue to subsist for a period to be determined, Prof. Okojie observed that attempts had been made over the years to run Medical programme using course credit system and that the hallmark of the new document is that it clearly apportions credit weightings to all the courses and activities.

"In line with global practice and to ensure that knowledge and skills are effectively imparted", Okojie said, "modern course delivery systems have been prescribed. Among core teaching facilities and modes of learning recommended are:

Clinical Skills Laboratory.

The use of the facility would represent a shift in the current mode of medical training to problem-based solving approach and the application of modern techniques which involves use of Mannikins and simulation materials. Clinical Skills Laboratory provides a learning platform in clinical, and information technology skills to certain level of competence before direct exposure to patients, which afford the learner and teacher advanced knowledge in a seemingly practical environment. The facility can also serve as a multi professional/inter professional interactive forum for communication skills development. The simulated patients also provide the learner a safe art of clerkship before direct contact with the real patient thus providing

a learning method that efficiently fills the gap between theoretical knowledge and clinical practice.

Classroom Equipment

Adoption of modern delivery method using ICT has become inevitable. Classrooms should be equipped with smart boards, document scanners and biometric scanners for lecture attendance.

E-learning materials and Research Information Platforms

E-learning materials accelerate understanding of courses taught and have become a veritable tool for learning. Research, generally, are meant to address social issues as well as deepening the knowledge and advancement in the field of studies. Information on the developments and applications in the field of study should be readily available."

On the above, Prof. Okojie said, "The availability of Nigerian Research and Education Network (NgREN) has made access to teaching (such as Telemedicine) and research information readily accessible, and all Nigerian universities should key into it."

Since the first erroneous publication of '11 years for Medical Programmes', NUC has sought to correct this misconception by widely circulating the Keynote Address and a Press Release on the matter. The Executive Secretary also took time to correct the misconception by speaking, extensively, on the matter at the recent recognition ceremony of the Edo University, Iyamho, held at the NUC Secretariat, Abuja.

RE: ACADEMY OF SCIENCE ACCUSES NUC OF TAKING BRIBES

The attention of the National Universities Commission (NUC) has been drawn to the publication in the Punch Newspaper of Tuesday, 1 March, 2016 titled "Academy of Science accuses NUC of taking bribes".

The Commission decided to address this issue via this medium because the publication is already in the public domain which makes it imperative to clear the air on some of the issues raised, by no less a person than a professor who is the President of the Nigerian Academy of Science (NAS) and a one-time Vice-Chancellor, who had hosted several Accreditation Panels and ought to know better.

It is important to state that Professor Oyewale Tomori, while delivering the Convocation lecture at the University of Abuja attempted to bring to disrepute the National Universities Commission and its accreditation system. It is pertinent to state that a good number of the accreditation assessors of programmes in the Science discipline in Nigerian Universities on which, he is casting aspersions, are members or potential members of the Academy.

For the avoidance of doubt, the NUC has a track record of Quality Assurance that stands out nationally and internationally. The Commission, from time to time, has been commended by different bodies on its accreditation procedure and overall Quality Assurance function. The NUC accreditation system has been understudied and replicated by other similar Quality Assurance agencies on the continent; and the Commission has also been invited at different times to facilitate the establishment of Quality Assurance agencies in countries without one. Currently, the Commission chairs the African Quality Assurance Network.

The Commission takes exception to the accusation of the NAS President that NUC officials collect brown envelopes during accreditation exercises. Even though the NAS President was quoted in the publication as having said that NUC alludes to the fact that those who give and take the envelopes are Professors, and that the NUC forgets that the results bear "NUC's accreditation", the fact still remains that accreditation is a peer-review exercise amongst academics all over the world. The Professor should therefore be bold enough to address the issue, if any, with his professional colleagues rather than point accusing fingers at the Commission.

In order to ensure the integrity of NUC accreditation exercise, there exists a widely publicised Code of Conduct guiding the conduct of Accreditation Exercise among the Panel members which expressly directs Universities not to have any financial dealing with assessors as their DTA, return transportation and honorarium for job done are taken care of by NUC. All panel members are also required to declare the existence of conflict of interest before being assigned the task. It is not clear to us whether Prof Tomori was involved in giving or taking the "brown envelop" as a Professor and a former Vice-Chancellor which he had never brought to the attention of the Commission.

On the issue of curriculum, it is pertinent to note that the Commission consistently engages in the review of its BMAS to meet National Developmental Objectives and International Best Practices. If Professor Tomori is current on issues of curriculum, he ought to know that the most recent review was in the year 2015 which was based on Labour Market Expectation of Nigerian Graduates and is on the NUC website.

It is curious that the Professor accused NUC of doing government's bidding. It is on record that whereas NUC is a statutory agency of the Federal Government of Nigeria, there has never been any form of interference from any quarter with regard to the outcome of the Commission's accreditation exercise from 1990 to date.

As the president of NAS, Prof. Tomori is in a position to constructively engage with the Commission towards the overall improvement of university education especially in the Sciences.

The National Universities Commission will continue to promote quality delivery of university education in Nigeria. This is our mandate, and the Commission remains willing to collaborate with well-meaning Nigerians and others to achieve it.

IMPLEMENTING STEPS FOR NEW MEDICAL SCHOOLS, **ACCREDITATION ISSUES AND THE NEW MINIMUM BENCHMARK (2015)** FOR THE MBBS/BDS PROGRAMMES

PROGRAMMES Stakeholders' meetings in the last two years and as a prelude to the formal release of the New Minimum Academic Benchmark (2015), proprietors of Medical and Dental Schools in Nigeria (both current and prospective) are requested to note the following implementing steps including relevant adjustments relating to accreditation of Medical/Dental Schools.

- 1. From 1st September 2015, both current and prospective proprietors of Medical and Dental Schools should:
- Write a letter to the Executive Secretary stating their intent and provide relevant information as available. a.
- On receipt, (if NUC has no obvious reasons to disqualify the application), they would be sent a copy of the b. BMAS for MBBS/BDS and advised firmly to ensure that they are strictly complied with.
- The setting up of medical schools is not an emergency exercise. To this end, prospective proprietors must own and c. have in place (prior to a request for a Resource Verification), a fully functional and well run tertiary type hospital. In the circumstance of the above not being in place, consideration for an affiliation with a tertiary governmentowned institution may be given only when the said university owns a medical institution fully functional with a minimum of 150 beds and a rural health medical unit. (See Appendix 4 of the BMAS).
- A Pre-clinical Accreditation would be expected to take place within two years of a positive Resource Verification. d. Students can only sit for the second MBBS professional examination (Anatomy, Physiology and Biochemistry) when they have a successful preclinical accreditation. The preclinical accreditation would, amongst others, concentrate largely on the Department of Anatomy, Biochemistry, Physiology, Pathology and Pharmacology and to a lesser extent, Community Health. All evaluated departments must have the minimum requirements in terms of academic staff, non academic staff and laboratory facilities. (See Appendix 3 of the BMAS)
- e. The Commission has now approved a Clinical Accreditation expected to take place within twelve months of a successful preclinical accreditation. Subsequent to that, a reaccreditation exercise will take place every five years.
- 2. With respect to established medical schools, (and irrespective of their accreditation status), it should be noted that only institutions that (by the deadline of March 20th, 2016) have requested and obtained formal approval from the National Universities Commission for a re-evaluation based on the following considerations would be allowed to admit students into the MBBS/BDS programmes from the 2016/2017 academic year:
- All Medical and Dental schools must have an approved, and appropriately utilized, Clinical Skills/Simulation a.
- Ensure strict adherence to the proper use of the course system for all approved programmes in Nigerian b. Universities. The implication of the above is that a particular programme (subject) is taught not only broken into cluster units of 1-4 but also have the components of university supervised examinations. For clarity, current end of posting examinations (practiced by some medical/dental schools) that neither have units allocated nor follow the standards of a University examination, do not conform to the Minimum Academic Standards as established by the National Universities Commission.
- Universities are strongly urged to immediately review their current methods of teaching medical and dental c. students to include more tutorials, self study group teaching, use of IT in the delivery of courses and simulation/competency based evaluations that must be signed by a lecturer not below the status of a senior lecturer. It must be noted that the confirmation of a successful simulation/competency based evaluation should be a mandatory requirement before the students are eligible to sit for the various professional/sessional examinations

3. Proprietors are urged to note the Essential Component changes of the new curriculum expected to be in use from the 2016/2017 academic session. Details of these changes are available in the New Minimum Academic standards booklet and at the National Universities Commission website. (www.nuc.edu.ng.) Major components include the following:

- (a) The approval of three alternative models viz;
- i. A seven year MBBS/BDS programme that encompass a mandatory seamless four-year acquisition of the B.Sc. (Basic Medical Science) with interest in either Anatomy/Physiology/Biochemistry. At the end of seven years, students would have acquired the Bachelor of Basic Medical Science, Bachelor of Medicine and Bachelor of Surgery degrees. In case of the dental programmes, the students would have acquired a degree in Basic Dental Science and Bachelor of Dental Surgery.
- ii. In order to allow for career change for interested non-medical health professionals, the Commission has also approved a four year programme leading to MBBS/BDS for interested and qualified graduates of Nursing, Pharmacology, Physiotherapy, Image Science, Paramedics, Anatomy, Physiology, Biochemistry and Pharmacology. It must be noted for such to be considered for admission they must have at the WAEC/NECO levels minimum credit scores in Mathematics, English, Physics, Chemistry and Biology at one sitting, prior to the admissions for their first degrees. They must also have a good CGPA.
- iii. Admission into universities based on the current six year programme would be allowed to continue as suitable alternative based on the discretion of the University.
- iv. It should be noted and emphasized that all the above degrees have the Bachelor appellation as they remain undergraduate programmes.
- (b) Specific periods of posting to the department of Family Medicine. The obvious implication here is that, the Universities should create the Department of Family Medicine following their due process.
- (c) Redesignation of the Department of Pharmacology to the Department of Pharmacology and Therapeutics. The department is now expected to provide relevant basic clinical teaching and conduct relevant professional examination in Pharmacology. They will also be expected to provide relevant clinical teaching in Therapeutics. All Universities should set in motion the machinery to achieve the above.
- 4. In view of the above essential component changes of the new curriculum, the Commission will be organising a National training for Medical teachers in Nigerian Universities. Details of the training would be made available shortly.

GUIDELINES ON PART-TIME AND SANDWICH PROGRAMMES IN NIGERIAN UNIVERSITIES

Below are guidelines for conducting Part-time and Sandwich programmes in Nigerian universities. All universities currently operating Part-time programmes are expected to comply with the guidelines on programme by programme basis.

Consequently, universities still interested in running Part-time programmes are advised to forward fresh applications to the NUC on programme by programme basis.

This is, however, subject to the readiness of the university to comply with the following extant guidelines on part-time programmes:

- 1. The admission and graduation requirements, Staffing, Library and physical facilities requirements must be in line with the Benchmark Minimum Academic Standards (BMAS) for the various full-time academic programmes;
- 2. For a programme to be eligible to run on part-time basis, the approved full-time equivalent must be available in the university, must have earned full accreditation and must be run within approved campuses;
- 3. The enrolment into part-time programmes must not exceed 20% of total students' population in the programme;
- The minimum duration of the part-time programmes must be 150% of the approved duration of the Full-Time equivalent;
- 5. Approval shall not be granted for part-time programmes in Environmental Sciences, Engineering/Technology, Law, Medicine/Medical Sciences, Pharmacy /Pharmaceutical Sciences, Dentistry; and Veterinary Science;
- 6. All admissions into part-time programmes must be through the Joint Admissions and Matriculation Board (JAMB). Part-time programmes must be run within approved campuses of universities where the human and material resources for the teaching of the programmes are domiciled, i.e. on the main campus of the university;
- 7. Part-time programmes shall be subjected to the NUC accreditation assessment upon maturity of the programme;
- 8. For any programme to be eligible for part-time mode, it must have produced two (2) sets of graduates and satisfied the Resource Verification Requirements.
- Commencement of a part-time programme MUST be subject to NUC's approval. Approval of commencement of all parttime programmes must be obtained.

The National Universities Commission shall not hesitate to apply appropriate sanctions on any university which violates any of the stipulated Guidelines on Part-Time and Sandwich Programmes.
