
Universities Must Equip us to Face Emerging Scenarios

ability to negotiate a better quality life for the people.

He also mentioned that government on its part would continue to encourage the universities and other tertiary institutions of higher learning to produce the necessary skilled manpower with a view to building a strong economy capable of sustaining the change agenda.

President Buhari said that in order to develop the nation's human capital and to show commitment to educational development, the Hon. Minister of Education, Malam Adamu Adamu directed the National Universities Commission (NUC) to develop a blue print for effective revitalization of university education in Nigeria.

He assured that the blue print would be carefully developed by some of Nigeria's finest academics and university administrators, with inputs from relevant stakeholders to facilitate Nigeria's transition from a resource based to knowledge based economy.

On the part of government part, the President pledged that his administration would continue to ensure that universities are run more efficiently and more prudently and challenged the university councils and management to respect the principles of good governance and rule of law in the administration of human, financial and reputational capitals of their institutions.

President Buhari also said that government was concerned about the incidences of financial recklessness in institutions of higher learning and universities and that government would act decisively in due course.

He congratulated the graduands and reminded them that society would assess their certificates by their actions and deeds.

He urged Nigerians to change the way they do things. "Nigerians must change their attitude towards education if they desire a new change and progress in the Country. Nigerians must change before it is too late".

According to the President, Nigeria's challenges were multiplying by the day and to tackle these challenges, would require a different and fresh perspective anchored towards education delivery.

He noted that, BUK was gradually becoming one of the prestigious universities in Nigeria and was emerging in its key discipline areas of Agriculture, basic and life Sciences, Social and Management Sciences, Computer Science and Information Technology as well as Engineering, adding that getting to this stage in the life of the university was by no means a mere feat.

He congratulated the university Senate, Council, congregation and Management who work tirelessly to ensure the success achieved so far in the university.

through which we shall overcome all challenges facing us as a nation, saying that he was encouraged by these prayers to change the nation to an economically prosperous nation.

He added that his administration was firmly aware of the promise it made to Nigerians to fight corruption, improve security and stimulate economic growth that would create more employment opportunities, "we shall continue to sacrifice our time and energy until we restore respect of all Nigerians."

He explained that his administration will continue to work with honesty and dedication to change the fortunes of the nation and he said that he was confident that they would emerge victorious in their efforts to effect positive change in the lives of Nigerians.

The Vice Chancellor, Professor Muhammad Yahuza Bello said in

his address that the university awarded bachelor's degrees to 5,098 qualified candidates from 15 faculties and one school, with 76 of these graduating with First Class Honours and 2, 559 were conferred with higher degrees and post graduate diplomas. Of this number, 70 PhD degrees received.

The Vice Chancellor said that the university had witnessed appreciable progress in the last one year with many projects completed and put to use, a number of new ones commenced. "One of the projects that was completed, commissioned and put to use is the Dangote Business School Building, constructed and furnished by the Dangote Foundation."

The Vice Chancellor noted that BUK had continued to maintain its record of academic excellence as the entire programme presented by the university for accreditation by the NUC, during the year under review scored full accreditation. Senate approval for the introduction of a mechanism for continuous internal quality assurance is another achievement, he said.

He said that the university had also continued to be globally competitive in other areas, such as wining research grants. "Grants secured during the year included; \$500,000 from MacArthur

Foundation, for Aminu Kano centre for Democratic Research and Development (Mambayya House), \$1,000,000 from the USAID for the establishment of the Nigerian Centre for Reading, Research and Development; and two grants totalling about £1,000,000 from the United Kingdom (UK) won by a research group in the College of Health Sciences for research into s n a k e b i t e a n d v e n o m development."

Professor Yahuza said implementations of earlier grants were progressing well and the Centre for Dryland Agriculture continued to make good progress in implementation of ACE grant from the World Bank.

"Similarly, implementation of \$400,000 DFID contributory grant to the Centre for Renewable Energy Research is about to be completed; with a one megawatt solar power

station about to be put to use on the Old Campus."

He said that when completed, it would be the largest solar power plant in the country and that as one of the nine universities benefitting from the Rural Electrification Agency, contract had been awarded for a three megawatt power plant for the New Campus.

The Chancellor of the university, HRM King Alfred P. Diete-Spiff, OFR, JP, DF, Sariyan II, and the Amanyanabo of Twon-Brass in his speech traced the development of universities visa-vis population growth in the country, saying that both had grown astronomically.

He said that universities had grown in number from 4 universities in the 1960's to the coming up of BUK in the 70's and "today we are talking of about 184 universities."

The nation's population, he said, had also grown from about 100 million in the 60's to about 180 million today, with the bulk of the majority making the youth, adding that the challenge facing the nation now was how to educate these youth who would take over the mantle of leadership.

"With numerous challenges facing the youth, it is incumbent for university like BUK to enlighten them on how to overcome it as well as face the future."

According to the chancellor, his vision for BUK was to be able to produce world class graduates that would contribute positively to the society while in competition with others for the benefits of humanity and to glory of God.

In his address, the Pro-Chancellor and Chairman of Governing Council, Professor Ibrahim O. Gambari, encouraged the graduates to step out into the world with a firm conviction that each had a responsibility and duty to become a part of the building block for a peaceful, progressive and prosperous country where everyone could give his place in dignity and hope.

Professor Gambari said he believed that BUK would be one of the best run universities under his Chairmanship and advised the graduands to see their certificates as the beginning of the beginnings and not as beginning of the end.

HME Commissions UNIPORT CEFOR Building

The Honourable Minister of Education (HME), Mallam Adamu Adamu, last Wednesday, commissioned the new building for the Africa Centre of Excellence in Oilfield Chemicals Research (CEFOR), University of Port Harcourt's (UNIPORT).

With the commissioning, the Centre relocated from its previous accommodation in the University's Emerald Energy Institute, an initiative jointly funded by the University and Total Exploration and Production and situated in the University of Port Harcourt's Institute of Petroleum Studies (IPS).

In a keynote address, the Minister, who was represented by the Executive Secretary of the National Universities Commission (NUC), Professor Abubakar A. Rasheed, MFR, commended the Management of the University of Port Harcourt for the achievements recorded by the University, especially in the performance of CEFOR, which, since inception, had graduated a total of 39 PhD students, more than any other ACE in Nigeria.

Mallam Admanu stated that there was a strong correlation between high quality knowledge and the economic growth of any country, adding that huge investments in education, especially tertiary education, are usually evident in a country's rate of development. Universities, however, should

not be saddled with the sole responsibility of national development, the Minister said. For this reason, there must be linkages between universities and the real world or industry, if the universities were to make any meaningful contribution to national development.

The Minister recalled the four pillars of the knowledge economy, as identified by the World Bank. According to the Bank, he said, "education and training of a skilled population, is key to creating, sharing and using knowledge. Also important, is a dynamic information from radio to the internet, which is required to facilitate the effective communication, dissemination and processing of information."

Yet another "pillar is a regulatory and economic environment that enables the free flow of knowledge, supports investment in Information and Communications Technology (ICT), and encourages entrepreneurship." The final pillar, Mallam Adamu said, was a network of research centres, universities, think tanks, private enterprises and community groups, necessary to tap into the growing stock of global knowledge as well as assimilate and adapt it to local needs and create new knowledge.

Declaring the CEFOR building open, the Minister expressed hope that the Centre would continue to achieve the goals for which it was established.

In his capacity as the NUC Executive Secretary, Professor Rasheed Stated that the decried Nigeria's low ranking in the Knowledge Economy Index, which he attributed, not only to inadequate investments in education but also a lack of faith in education as the centrepiece of development.

Cognisant of the importance of

education, the Commission had embarked on a reform of the Nigerian University System (NUS). To effectively do this, he said NUC must reposition itself, to efficiently and effectively regulate the nation's universities.

The Commission was, therefore in the process of reviewing and reappraising its commitment to university education, prior to approaching the government for improved funding. He, however, noted that not all challenges in the system were dependent on funds and urged universities to also conduct an internal assessment, with a view to correcting attitudinal vices among staff and students.

Professor Rasheed commended the University's relationship with its partners, the university community and all stakeholders. He applauded the teamwork evident among staff and faculty of CEFOR as well as the Centre's relationship with the University Management, adding that this was a key component in CEFOR's success.

Earlier, in his welcome remarks, the Vice-Chancellor of the University, Professor Ndowa E. S. Lale, recognised the impact of CEFOR on the University, adding that the practice of multi-disciplinary research became very effective because of the collaborative effort of staff. He stated that programmes under CEFOR and other institutes in the University were structured in such a way that students graduate within the stipulated period of time.

Professor Lale observed that CEFOR had also introduced the concept of shared resources and services among various Departments and faculties in the University, which, was expected, to minimise duplication of efforts and help to optimise the utilisation of laboratory

equipment and personnel. He noted the need to devise alternative means of funding CEFOR, in addition to the World Bank's grant, to guarantee its sustenance beyond the expiration of Bank funds and expressed optimism that the University's "can do" spirit would propel the Centre in the right direction.

The Vice-Chancellor expressed gratitude to the Centre Leader, Professor Ogbonna Joel, for his vision and uncommon dedication to duty, noting that Professor Joel has proven that Nigerians can measure up to global best practices. The Vice-Chancellor commended the Academic Board, staff and members of the ACE steering Committee, for their commitment to achieving excellence in the Centre.

Giving a progress report of CEFOR, Professor Ogbonna Joel highlighted some of its achievements to include enrolling a total of 130 PhD students, since inception. Of the 53 students admitted in the first batch, 37 graduated in March, 2017 and about 90% of them, gainfully employed. The Centre had admitted 70 new PhD students during the 2016/2017 session, nine of which are regional students and were also expected to graduate within the target time.

In the past three years, CEFOR had also graduated 293 MSc. students, all within the target 12-month period. It had trained a total of 383 participants in short courses and internship programmes, while more than 200 participants had been certified as Environmental Professionals with the National





Registry of Environmental Professionals (NREP), USA.

Other achievements, Professor Joel stated, included attainment of NUC accreditation for 12 of the Centre's programmes; a gap analysis conducted in the Centre's Petroleum and Gas Engineering programmes, in June, 2017; publication of over 100 papers in reputable journals, from CEFOR students' research work and attracting more than 60 experts from both the academia and industry. He noted that CEFOR had also entered into partnerships with industry, professional bodies and foreign universities, as part of efforts to ensure that the Centre delivers on its mandate.

In a goodwill message, the World Bank Co-Task Team Lead, Ms. Aisha Garba, expressed pleasure at the progress recorded in improving higher education, through the ACE project, adding that the Nigerian ACEs were showing a

lot of promise in delivering on their mandate. She commended them for the results achieved, so far, particularly in the quality of education, relevant applied research and strong universityindustry linkages. She commended CEFOR, in particular, for its progress in student enrolment and for graduating a significant number of MSc and PhD students within the specified time frame.

Despite the progress recorded by the Centres, especially in student enrolment, the increasing demand for higher education has doubled over the last five years, leaving access at five percent, a fifth of the 25% global average.

Ms. Garba noted that there were challenges of skills shortages in addressing development challenges and poverty reduction in Africa, particularly in the areas of Science, Technology, Engineering and Mathematics (STEM). She decried a situation where Engineering graduates amounted to less than 10 percent

of total graduates in the nation, while their counterparts in the social sciences, business and law programmes, accounted for more than 50 percent.

Ms. Garba stated that education remain a priority for the World Bank, because of its potential to transform the African continent. Africa must, therefore, must work together, to ensure the success of the ACE project. The ACEs, she said, must share resources and sustainable solutions as well as continue to train students across borders.

The Co-Task Team Lead informed guests that the Bank was preparing to scale up the ACE project, through the Africa Centre of Excellence Impact Project, which would enable universities in Africa to respond to the dynamics of the Africa labour market, by ensuring the production of quality graduates. The Bank, she said, recognised that all ACEs across Africa must work hard to resolve their challenges and ensure the success of the ACE project, by

educating the next generation of scientists, researchers, leaders and innovators.

Giving a reassurance of the Bank's commitment to supporting the Nigerian government in its efforts to transform the society and economy, by investing more in education, Ms. Garba stated that the Bank was also optimistic of a continued collaboration and partnership with the Nigerian government.

In another goodwill message, fifth Vice-Chancellor of the University, Professor Nimi D. Briggs, thanked the Choba community for accommodating the University and ensuring an enabling environment for it to thrive. He explained that the decision to locate CEFOR outside the University was to guarantee that academic work progressed, unhindered.

He expressed appreciation to the University community, without which support and collaboration the successes recorded would have been impossible. He commended the Vice-Chancellor of the University as well as his successors, such as Professors Joseph A. Ajienka and Dom Baridam, for keeping the University's dream alive.

Immediate past Vice-Chancellor

of the Institution, Professor Joseph Ajienka, commended the NUC Executive Secretary for the proposed reforms in the NUS, describing the Executive Secretary as an erudite and committed scholar as well as a friend of the University. Professor Ajienka thanked Professor Briggs for believing in industry partnership and for the critical role he played in securing the land for the Institute of Petroleum Studies, which houses CEFOR. He also expressed appreciation to Professor Joel and the Deputy Centre Leader, CEFOR, Professor Onyewuchi Akaranta, for putting together the proposal that won UNIPORT the Centre of Excellence.


Knowledge, Major Currency in Today's Economy - Rasheed

The Executive Secretary of the National Universities Commission (NUC), Professor Abubakar A. Rasheed, MFR, has described knowledge as the major currency in today's knowledge economy.

The Executive Secretary said this during the launch of the book "Internationalisation of Higher Education in Nigeria", which took place the University of Port Harcourt's Institute of Petroleum Studies (IPS).

In a presentation, titled "The Brain Gain Policy and the Advancement of Higher Education in Nigeria", Professor Rasheed stated that a true university had a universal spirit, devoid of cultural, political ethnic and religious barriers.

He noted that in a true university system, members of the

community learnt to tolerate themselves, regardless of their individual differences.

He recalled that the oldest operating university in the world was the University of Al-Karaouine, in Morocco, the oldest operating university in Europe was the University of Bologna, Italy, while the oldest operating university in the English-speaking world was Oxford.

Though these institutions started as religious centres, they were

operated under strict democracy and soon realised that if useful knowledge was to be generated it was imperative not to restrict the institutions. They were therefore opened up to people from different climes and creeds and this ultimately resulted in research and breakthroughs in science, mathematics, engineering, medicine and other important fields.

He said that globalisation had its origin in university education, adding that whenever a Professor of Nigerian extraction was, appointed to a Chair in a foreign university, it was not necessarily because the university could not find or nurture one of its own to the Chair but rather, to sustain the culture of universality of education and allowing for cultural co-habitation, bringing people of different backgrounds together to enrich the university community.

The Executive Secretary stated that Nigerian universities and graduates were not ranking high enough because they had forsaken the cardinal principles of university education. He decried a practice in many Nigerian universities, where principal officers were appointed based on political, ethnic and religious inclinations, rather than credibility, potentiality and accountability. He added that, until the system embraced the universality of education, significant progress could not be made.

Professor Rasheed stated that a practice where Nigerian students travelled to other climes, in pursuit of education, was not necessarily an indication that the standard of education was poor. He noted that in the western world, it was normal and part of the internationalisation of education for Americans to seek educational pursuits in Europe and Asia and vice versa.


The NUC Scribe lamented the irregularity of the academic calendars in Nigerian universities, adding that no two universities in Nigeria had the same academic calendar. This, he said, was a major threat to internationalising education in the country.

He lauded the Africa Centre of Excellence (ACE) project for its potential to attract foreign students to the Nigerian University System (NUS), as evidenced in the enrolment of regional students from West and Central Africa, across all 10 ACEs in Nigeria. He commended the University of Port Harcourt for its drive in reaching out to academics in the diaspora and for the University's efforts at sustaining the qualities of a universal university.

Earlier in a welcome address, the Chairman of the occasion and Emeritus Professor, Nimi D. Briggs, noted that the University had gathered momentum at the turn of the millennium, to take it to greater heights, under the guidance of the NUC. He commended the efforts of everyone who had contributed to the publication of the Book, particularly the scholars, who, he said, were carefully chosen academics from the diaspora.

Presenting the Book, Professor Joseph A. Ajienka expressed appreciation to all who had made the event possible, especially the scholars, for their immeasurable contributions. He informed guests that the University of Port Harcourt had a brain gain programme approved by the University's Senate.

Unveiling the Book, the Executive Secretary described it as "a well-researched publication" and recommended it to everyone who was passionate about university education. He congratulated the contributors for their input and wished them success in all their future endeavours.

The final rounds will be held at the United Mations Headquarters in Geneva from 15 to 20 July.

Each year undergraduate and mosters' level students who wish to participate in the Compolition submit written legal arguments for the opposing sides in a fictional dispute involving some of the burning human rights issues of the day. The teams with the highest scores from each of the five UN regions are then invited to participate in the final, oral rounds in the Human Rights Council Chamber in the Palais des Nations. The case is heard by a panel of eminent international jurists, including judges from international tribunals. Many participants have described participation in the Moot as the highlight of their studies.


In 2018 the Competition will for the first time be presented not only in English, but also in French. In future years the other UN languages, namely Spanish, Chinese, Russian and Arabic, will also be used.

The teams that are selected to participate in the final rounds in Geneva are expected to cover their own traveling costs as well as accommodation and meals, although limited financial assistance is available.

NUC MAKES HISTORY IN RANKING OF OPEN EDUCATIONAL RESOURCES (OER)

The National Universities Commission has made history in conducting the first-ever ranking of Open Educational Resources (OER) held in institutional repositories. It is the first exercise of its kind in the world and it was initiated by the Executive Secretary of NUC, Professor Abubakai Rasheed, mni,MFR for application in the Nigerian University System. The exercise showed that with 12,070 quality OER holdings presented by 50 universities for the inaugural exercise, Nigerian Universities are now among the best in Africa in OER. It is estimated that with full release of the OER holdings and participation by all universities, this number may quadruple in the next two years making the Nigerian University system the richest in OER in Africa. The OER ranking exercise is to be conducted twice a year.

Open Educational Resources (OER) are teaching, learning and research materials in any medium, digital or otherwise, that reside in the public domain or have been released under an open license that permits no cost access, use, adapt and redistribute by others with no or limited restrictions. They are technology-enabled, open provision of educational resources for consultation, use and adaptation by a community of users for non-commercial purposes. Materials that constitute OER include curriculum maps, cruinse materials, beatbooks, streaming videos, pictorial materials, multimedia applications; podcast, and any other materials that have been designed for use in teaching and learning environment.

The DER ranking exercise was conducted by the 12-member National Experts Group on OER Ranking (NEGOR) and a four-person team of external experts from outside Nigeria.

Fifty universities that participated in the inaugural edition were ranked by (a) ownership (federal, State and private) and (b) generation within ownership. The results are shown below.

Introduction:

The Federal Executives Council at its meeting held on 28th July 2010 approved that Nigeria should adopt the provisions of the International Financial Reporting Standards (IFRS) and International Public Sector Accounting Standards (IPSAS) for Private and Public Sectors respectively.

Consequently, the Federation Accounts Standards Allocation Committee (FAAC) at its meeting held on 13th June 2011 setup a Sub-Committee to provide a roadmap for the Implementation of IPSAS in the three tiers of government in Nigeria.

The Roadmap to the adoption of IPSAS was phased as follows:

- Full Adoption of IPSAS Cash effective from 1* January, 2014.
- Adoption of IPSAS Accrual effective from 1" January 2016.

The National Universities Commission (NUC) has commenced the IPSAS implementation project that will enable a seamless adoption of the IPSAS accrual in the preparation and presentation of Financial Statements in line with the directives of Federation Accounts Allocation Committee (FAAC) Sub-Committee on implementation of IPSAS.



GUIDELINES ON PART-TIME AND SANDWICH PROGRAMMES IN NIGERIAN UNIVERSITIES

Below are guidelines for conducting Part-time and Sandwich programmes in Nigerian universities. All universities currently operating Part-time programmes are expected to comply with the guidelines on programme by programme basis.

Consequently, universities still interested in running Part-time programmes are advised to forward fresh applications to the NUC on programme by programme basis.

This is, however, subject to the readiness of the university to comply with the following extant guidelines on part-time programmes:

- 1. The admission and graduation requirements, Staffing, Library and physical facilities requirements must be in line with the Benchmark Minimum Academic Standards (BMAS) for the various full-time academic programmes;
- 2. For a programme to be eligible to run on part-time basis, the approved full-time equivalent must be available in the university, must have earned full accreditation and must be run within approved campuses;
- 3. The enrolment into part-time programmes must not exceed 20% of total students' population in the programme;
- 4. The minimum duration of the part-time programmes must be 150% of the approved duration of the Full-Time equivalent;
- 5. Approval shall not be granted for part-time programmes in Environmental Sciences, Engineering/Technology, Law, Medicine/Medical Sciences, Pharmacy /Pharmaceutical Sciences, Dentistry; and Veterinary Science;
- 6. All admissions into part-time programmes must be through the Joint Admissions and Matriculation Board (JAMB). Part-time programmes must be run within approved campuses of universities where the human and material resources for the teaching of the programmes are domiciled, i.e. on the main campus of the university;
- 7. Part-time programmes shall be subjected to the NUC accreditation assessment upon maturity of the programme;
- 8. For any programme to be eligible for part-time mode, it must have produced two (2) sets of graduates and satisfied the Resource Verification Requirements.
- 9. Commencement of a part-time programme MUST be subject to NUC's approval. Approval of commencement of all parttime programmes must be obtained.

The National Universities Commission shall not hesitate to apply appropriate sanctions on any university which violates any of the stipulated Guidelines on Part-Time and Sandwich Programmes.
