Life Returns to Campuses as ASUU Suspends Strike

t was a huge sigh of relief for students in the nation's public universities' campuses as Academic Staff Union of Universities (ASUU) announced the suspension of its three months industrial action penultimate Thursday ago. This followed a two and half hour meeting and subsequent signing of document between the Federal Government delegation, led by the Minister of Labour and Employment, Senator Chris Ngige and his Education counterpart, Malam Adamu Adamu and ASUU in Abuja.

The strike was suspended after the 10th marathon meeting between the government delegation and ASUU leaders which precipitated a final agreement on a new timelines based on the earlier 2017 Memorandum of Action, now regarded as MoA 2019. The MoA was signed by both parties which eventually sealed the long

negotiation between the union and government.



2018, and subsequent MoUs, insisting that all those years government have not demonstrated enough commitment to meet their demands.



Addressing newsmen after signing the Memorandum of Action (MoA), the Minister of Labour and his Education counterpart jointly expressed that "This is going to be a conclusive and reconciliatory meeting between Federal Government and ASUU. They both noted that the FGN and ASUU have unanimously resolved the eight contentious issues that prolonged the strike.

The ASUU President, Professor Biodun Ogunyemi concurred with the Minister on the issues in dispute, stating that the suspension of the strike was approved at the National Executive Council (NEC) meeting of the union after considering offers by the federal government.

He said "while we put a close to

this phase of struggle, it is our hope and desire that the Nigerian governments (federal and state) will play the roles expected of them in order to make the new memorandum work."

Professor Ogunyemi explained the MoA contained in the document and reached by the parties to include:

- 1. In addition to N20 billion for 2018, the sum of N25 billion would be released in April/May, 2019, after which government would resume full implementation of the MoU of 2013.
- 2. Part-payment of the outstanding arrears of Earned Academic Allowances (EAA); defraying the balance up to 2018 in four tranches within 36 months; and mainstreaming further payments of EAA into the annual budgets, beginning from 2019 budget.
- 3. Presidential Initiative on Continuous Audit (PICA) verification and the release of the arrears of salary shortfalls at

Federal University of Agriculture, Makurdi (UAM), not later than 15th February, 2019.

- 4. Strengthening the Consultative Committee of state-owned Universities (CCSOU) inaugurated on Monday, 28th January, 2019 to look into the issues of proliferation, underfunding and governance to consistently deliver on its mandate.
- 5. Payment of outstanding Earned Academic Allowances, arrears of all eligible staff of the University of Ilorin, especially

loyal ASUU members whose appointments were illegally terminated by 7th February, 2019.

- 6. Acknowledgement and appreciation of government for facilitating the release of the final letter of approval for the granting of license to NUPEMCO.
- 7. Visitation to all Federal Universities would commence tentatively by 11th March, 2019.
- 8. Provision of documented guidelines on procedures and roles of parties in the process of negotiating FGN-ASUU Agreement of 2009 which would commence not later than 18th February, 2019 and end by Friday, 29th March, 2019.

While highlighting the stand of the union on the reached agreement,



Professor Ogunyemi noted that the union's National Executive Committee (NEC) had resolved that the current strike be suspended conditionally with effect from 12:01 a.m. on Friday, 8th February, 2019.

He, however, warned that government must not renege on its part of the agreement as reflected in the 2019 Memorandum of Action. ASUU, according to him, shall resume its suspended strike as the union deems necessary, if the spirit and the letter of the agreement were not adhered to subsequently.

NUC to Partner NESG on Review of Education Blueprint

The Nigeria Economic Summit Group (NESG) penultimate week ago visited the Executive Secretary, National Universities Commission (NUC), Professor Abubakar Adamu Rasheed, mni, MFR, FNAL, in his office, for collaboration in the area of the review of the NUC blueprint on the rapid revitalization of university education in Nigeria.

Addressing the delegation, the NUC Scribe said that Nigerian Universities must be revitalized to unleash it potentials as a catalyst for socioeconomic development in Nigeria.He lauded the envisaged collaboration with the NESG, describing it as the first of its kind in the several attempt to reform university education in the country. According to him, "there is a missing link between the university system and the industrial sector and this has over time affected the type of graduates we produce from our universities as most of them are not employable".

He expressed hope that the collaboration would bridge the gap by unravelling the skill-needs of the industrial sector thereby, empowering the Universities to adequately train their students to fit into the labour

market upon graduation.

The Executive Secretary bemoaned the infrastructural decay in the universities which had widened the gap between the universities and the industrial channeled to areas of needs, leaving the universities in a state of infrastructural deficit, inadequate man-power training and learning resources.

Prof. Rasheed stressed that the

sector, noting that the NUS was not in shortage of interventions, as they have continued to receive funding in terms of grants and special interventions from Tertiary Education Trust Fund (TETFund), Central Bank of Nigeria (CBN), Private individuals and Philanthropists, the World Bank, as well as Budgetary Allocation from the federal government. He however, noted that such interventions were often not properly

NUS was capable of driving the proposed strategic goals of revitalization, which, he noted, covered specialised areas like Agriculture, Entrepreneurship and skill development, Engineering, Information Technology, amongst others. NUC, he said, would forward the recommendation to the government, while on its part provide the necessary guidance and monitoring to ensure that the





recommendations are well implemented.

According to him, the Student Industrial Work Experience Scheme (SIWES) programme had outlived its usefulness as Universities has risen from zero in the last twenty years to 75 and still counting.

He hinted that plans were on ground to also provide "safety nets" in form of loan or grants for students who may secure two parties synergise, identify challenges that had over the years led to graduate unemployment.

Mr. Seun noted that the group was already collaborating with National Institute for Policy and Strategic Studies (NIPSS), Kuru, to seek

most students hardly find placement due to over subscription to the programme as well as shrinking number of industries and lack of proper monitoring of SIWES students to ensure they acquired the relevant skills.

He called for a review of the scheme and for the industrial sector to fund researches in the NUS on areas beneficial to them, as a way of promoting academic excellence and meeting the aspirations of employers of labour.

Professor Rasheed informed the NESG delegation that the commission was making effort to solve the challenges of access to University Education in Nigeria, adding that the number of Private

admission into these Private Universities whose parents could not afford the fees. This, he said, would enable private universities meets their admission quota, which they hardly achieve.

The Executive Secretary beckoned on the NESG to bring on board the Executive Secretaries of Tertiary Education Trust Fund (TETFund) and Industrial Training Fund, to be part of the initiative.


Responding on behalf of the Chief Executive Officer, Head of Policy Intelligence NESG, Mr. Seun Ojo expressed gratitude to the Executive Secretary for providing the platform for Captains of Industries and the academics to meet. He stated that the initiative would enable the

ways of advancing education in Nigeria. He assured the Executive Secretary that all critical stakeholders will be on brought on board as they have found them critical in the pursuit of a productive and result oriented education system.

To build a knowledge and solutiondriven University, he noted that the group had trained academics from 26 universities in South Africa on Entrepreneurship Development in Higher Education.

He however lamented that NESG collaborated with General Electric to host similar training in Nigeria, but failed because of lack of enabling platform for the programme to take-off. He pledged that NESG was willing to

Professor Taura Emerges New VC Sule Lamido University

The Governing Council of Sule Lamido University (SLU), Kafin Hausa, Jigawa State has appointed Professor Lawan Sani Taura, the new Vice-Chancellor of the University. His appointment became effective from December 2018. He replaced Professor Abdullahi Yusuf Ribadu, whose tenure as the pioneer Vice-Chancellor has elapsed.

Following his appointment, the new Vice-Chancellor last week visited the Executive Secretary, National Universities Commission (NUC), Professor Abubakar Adamu Rasheed, *mni*, *MFR*, *FNAL*, to familiarise himself with the workings of the Commission and the Nigerian University System (NUS).

Born on 10th June, 1960, the new Vice-Chancellor, who is a Professor of Solid State Physics, hails from Taura local Government Area of Jigawa State. He started his educational career by obtaining the Nigeria he graduated with the Bachelors of Science (B.sc) Physics in 1990; M.sc Physics from the Ahmadu


Certificate in Education (NCE) with distinction in 1985 from the Gumel Advanced Teachers' College, Kano.

Thereafter, he proceeded to the Bayero University Kano, where Bello University (ABU) Zaria in 1999, with his area of specialisation in Solid State Physics and a PhD from Bayero University Kano in 2009 with specialisation in Computational Solid State Physics.



Between 1992 and 1995, Professor Taura was an Assistant Lecturer in the Department of Physics in BUK and rose through the ranks to become a substantive Professor metamorphosed to Jigawa State University (now Sule Lamido University) Kafin Hausa in 2013. His current research interest is in Computational Solid State Physics.

The new Vice-Chancellor has also undertaken several Community services which include: Chairman, Committee for the Recruitment of Teachers for the Ministry of Education. Science and

He is a member of Nigerian Association of Mathematical Physics (NAMP) and Nigerian Association of Physics (NIP) and also a serving Member of the Editorial Board of the Journal of Transactions of the Nigerian Association of Mathematical Physics.

NUC MAKES HISTORY IN RANKING OF OPEN EDUCATIONAL RESOURCES (OER)

The National Universities Commission has made history in conducting the first-ever ranking of Open Educational Resources (OER) held in institutional repositories. It is the first exercise of its kind in the world and it was initiated by the Executive Secretary of NUC, Professor Abubakar Rasheed, mni,MFR for application in the Nigerian University System. The exercise showed that with 12,070 quality OER holdings presented by 50 universities for the inaugural exercise, Nigerian Universities are now among the best in Africa in OER. It is estimated that with full release of the OER holdings and participation by all universities, this number may quadruple in the next two years making the Nigerian University system the richest in OER in Africa. The OER ranking exercise is to be conducted twice a year.

Open Educational Resources (OER) are teaching, learning and research materials in any medium, digital or otherwise, that reside in the public domain or have been released under an open license that permits no-cost access, use, adapt and redistribute by others with no or limited restrictions. They are technology-enabled, open provision of educational resources for consultation, use and adaptation by a community of users for noncommercial purposes. Materials that constitute OER include curriculum maps, course materials, textbooks, streaming videos, pictorial materials, multimedia applications, podcast, and any other materials that have been designed for use in teaching and learning environment.

The OER ranking exercise was conducted by the 12-member National Experts Group on OER Ranking (NEGOR) and a four-person team of external experts from outside Nigeria.

Fifty universities that participated in the inaugural edition were ranked by (a) ownership (federal, State and private) and (b) generation within ownership. The results are shown below.

GUIDELINES ON PART-TIME AND SANDWICH PROGRAMMES IN NIGERIAN UNIVERSITIES

Below are guidelines for conducting Part-time and Sandwich programmes in Nigerian universities. All universities currently operating Part-time programmes are expected to comply with the guidelines on programme by programme basis.

Consequently, universities still interested in running Part-time programmes are advised to forward fresh applications to the NUC on programme by programme basis.

This is, however, subject to the readiness of the university to comply with the following extant guidelines on part-time programmes:

- The admission and graduation requirements, Staffing, Library and physical facilities requirements must be in line with the Benchmark Minimum Academic Standards (BMAS) for the various full-time academic programmes;
- 2. For a programme to be eligible to run on part-time basis, the approved full-time equivalent must be available in the university, must have earned full accreditation and must be run within approved campuses;
- 3. The enrolment into part-time programmes must not exceed 20% of total students' population in the programme;
- The minimum duration of the part-time programmes must be 150% of the approved duration of the Full-Time equivalent;
- Approval shall not be granted for part-time programmes in Environmental Sciences, Engineering/Technology, Law, Medicine/Medical Sciences, Pharmacy /Pharmaceutical Sciences, Dentistry; and Veterinary Science;
- 6. All admissions into part-time programmes must be through the Joint Admissions and Matriculation Board (JAMB). Part-time programmes must be run within approved campuses of universities where the human and material resources for the teaching of the programmes are domiciled, i.e. on the main campus of the university;
- Part-time programmes shall be subjected to the NUC accreditation assessment upon maturity of the programme;
- For any programme to be eligible for part-time mode, it must have produced two (2) sets of graduates and satisfied the Resource Verification Requirements.
- Commencement of a part-time programme MUST be subject to NUC's approval. Approval of commencement of all parttime programmes must be obtained.

The National Universities Commission shall not hesitate to apply appropriate sanctions on any university which violates any of the stipulated Guidelines on Part-Time and Sandwich Programmes. Signed
