He urged Higher Education Institutions to avail themselves and work in line with the existing draft National Policy on Open Educational Resources for Education to develop the needed materials on OER.

The National Policy was prepared under the auspices of the Executive Secretary, National Universities Commission.

The National Open Educational

According to him, after significant changes and improvement, the OER document was validated by stakeholders, the Nigerian Council on Education, in September, 2017.

Resources (OER) Material Development Workshop for HEIs in Nigeria was organized by the Regional Training and Research Institute for Distance and Open Learning (RETRIDOL) and National Open University of Nigeria (NOUN) in Collaboration with the Commonwealth of Learning (CoL).

He said that the Zero draft of the document was prepared on behalf of the Common Wealth of Learning by Dr. Jane-Frances The Minister said that the document was forwarded to Federal Executive Council for final approval. "The same document was later presented at the 2nd world congress on OER and Nigeria was singled out by different speakers and praised with commendation in recognition of its speedy way the country produced it first-ever draft policy on OER."

The country received the commendation in September, 2017 at the 2nd world OER

from Nigeria.

"This singular action, he said, placed Nigeria as a leading country in Africa on the deployment of OER materials to support education."

In his address, the Vice Chancellor, NOUN, Professor Abdallah Uba Adamu stated that NOUN as a specialized university could not operate in isolation from the rest of other Nigerian universities. He therefore expressed his happiness that NOUN had been returned under the auspices of the NUC for better quality control as gazetted in 2018.

On the other hand, Prof. Adamu attributed his progress in life to the encouragement and opportunities availed to him by the representative of the HME and NUC Executive Secretary when he was Vice Chancellor, Bayero University, Kano. The VC also praised all those who championed the development of

OER in NOUN and specially recognized the support of CoL and RETRIDOL.

Professor Adamu emphasized that Open Education Resources remained critical to the required support and sustainability of NOUN in its mandate of providing higher education to wider prospective candidates regardless of gender, sex, age or condition of service.

He enjoined the participants to be opened in their approach and shape not only the direction of educational systems but accelerate the creation and adoption of more OER.

Earlier in his welcome remarks, the Director, RETRIDOL, National Open University, Professor Patrick E. Eya welcomed everyone on behalf of NOUN RETRIDOL and CoL to the 3-day workshop on OER Material Development for A c a d e m i c Staff from Universities in Nigeria.

In addition to this he said staff of NOUN had just concluded another seminar workshop in partnership with OER Africa. This and the earlier workshop underscored the global importance of the use of Open Education Resources as tool to mitigate the rising cost of educational materials globally especially the less privileged and unreached population of African people.

The Director enthused that "the OER movement which is championed by UNESCO since the Paris Declaration of 2012 has grown in leaps and bounds in the Americas, Europe and in Asia."

He encouraged that Africa must join the movement in order to catch up or match with the world. To achieve this, he assured that the participants of the workshop would be treated with details of the movement started by Massachusetts Institutes of Technology (MIT) in the USA.

While in the Commomwealth he

said, COL had been championing the OER movement and their workshop was one of the COL's effort to train Academic staff in Nigerian universities on how to use OER to develop learning materials for use by both staff and students of higher Education Institutions.

Professor Eya hoped that apart from training on OER application in the development of learning





materials, it would awaken the NUC and other relevant agencies of the Federal Ministry of Education on the need to quicken action on National OER Policy and National OER Repository.

The Director finally recognized the presence of the Permanent Representative of ECOWAS and its role in this regards. He requested the ECOWAS to facilitate Nigerian OER movement to include other areas of West African Countries in the Sub-region.

While making his remarks, the Permanent Representative, Permanent Mission of Nigeria to ECOWAS Commission, Ambassador Babatunde A.

expressed his commitment to always be part of this laudable





RE: MORATORIUM ON PART-TIME PROGRAMMES

he National Universities Commission, cognizant of the need to streamline the operations of Part Time and Sandwich programmes in Nigerian universities, had through a publication in the print media, including the Guardian and Sun Newspapers of Monday, 19th March, 2012, placed a moratorium on admission into parttime programmes in Nigerian universities. In the publication, the universities were requested to fully disclose all Part-Time and Sandwich programmes, with respect to enrolment and staffing profile, within four weeks of the publication, and to conduct in-house staff and student audit and forward same to the Commission. As a follow up to this, the Commission vide a letter dated 14 January, 2013, sent a reminder to the universities requesting those that were yet to provide information on their Part-Time and Sandwich programmes as well as affiliation arrangements to do so on or before 15 February, 2013.

GUIDELINES ON PART-TIME AND SANDWICH PROGRAMMES IN NIGERIAN UNIVERSITIES

Below are guidelines for conducting Part-time and Sandwich programmes in Nigerian universities. All universities currently operating Part-time programmes are expected to comply with the guidelines on programme by programme basis.

Consequently, universities still interested in running Part-time programmes are advised to forward fresh applications to the NUC on programme by programme basis.

This is, however, subject to the readiness of the university to comply with the following extant guidelines on part-time programmes:

- 1. The admission and graduation requirements, Staffing, Library and physical facilities requirements must be in line with the Benchmark Minimum Academic Standards (BMAS) for the various full-time academic programmes;
- 2. For a programme to be eligible to run on part-time basis, the approved full-time equivalent must be available in the university, must have earned full accreditation and must be run within approved campuses;
- 3. The enrolment into part-time programmes must not exceed 20% of total students' population in the programme;
- 4. The minimum duration of the part-time programmes must be 150% of the approved duration of the Full-Time equivalent;
- 5. Approval shall not be granted for part-time programmes in Environmental Sciences, Engineering/Technology, Law, Medicine/Medical Sciences, Pharmacy /Pharmaceutical Sciences, Dentistry; and Veterinary Science;
- 6. All admissions into part-time programmes must be through the Joint Admissions and Matriculation Board (JAMB). Part-time programmes must be run within approved campuses of universities where the human and material resources for the teaching of the programmes are domiciled, i.e. on the main campus of the university;
- 7. Part-time programmes shall be subjected to the NUC accreditation assessment upon maturity of the programme;
- 8. For any programme to be eligible for part-time mode, it must have produced two (2) sets of graduates and satisfied the Resource Verification Requirements.
- 9. Commencement of a part-time programme MUST be subject to NUC's approval. Approval of commencement of all parttime programmes must be obtained.

The National Universities Commission shall not hesitate to apply appropriate sanctions on any university which violates any of the stipulated Guidelines on Part-Time and Sandwich Programmes.
