NUC, Major Shareholder in NUPEMCO

— Prof. Rasheed

he Executive Secretary, National Universities Commission (NUC), Prof. Abubakar Adamu Rasheed, mni, MFR, FNAL, has said that with NUC's investment of Fifty Million Naira in the Nigeria University Pension Management Company (NUPEMCO), it was an important shareholder in the pension body.

In his address at the maiden consultative meeting of NUPEMCO Shareholders and Stakeholders, held last Wednesday, at the NUC conference room, Professor Rasheed expressed delight that the universities were responding to the call for investment and ownership of NUPEMCO.

While lamenting that the numbers were still low, the Executive Secretary acknowledged that when others see the seriousness of NUPEMCO, as a viable Pension Fund Administrator (PFA) they would have no choice but to join.

He said NUC had invested an

transparency, probity and accountability for the sake of the shareholders.

He observed that if NUPEMCO became well-managed and coordinated, success was already awaiting the pension company as it would likely inherit over 200,000 staff presently in the academia, consisting of both, academic and non-academic staff. "With this structure in place, NUPEMCO would surely grow and make more money."

NUPEMCO, the Executive Secretary stressed, remained the property of all the stakeholders, reiterating that NUC would given a fair knowledge of the amount they have invested so far.

The NUC scribe advised NUPEMCO not to expand unnecessarily with too many branches and offices, but to keep things as simple as possible for efficiency purposes.

He said consent form should be given to people or institutions to complete without forcing it on them and that NUPEMCO should ensure that retirees start receiving their pension immediately after retirement.

He commended the National Association of Academic Technologies (NAAT), whom, he recognised, as closest to the academics as well as ASUU, Non-Academic Staff Union (NASU), Tertiary Education Trust Fund (TETFund) and the management of NUPEMCO, for the success of the meeting.

He urged NUPEMCO to put in a functional system that would work

make sure that the entire universities in Nigeria invest in it.

He also expressed his satisfaction that the Academic Staff Union of Universities (ASUU) was the principal partner, being the owners of the majority shareholding.

While advocating for transparency in the company, Professor Rasheed reiterated that every shareholder must be In the present Federal Government's pension structure, he stated that many pensioners die awaiting their payment due to the cumbersome process, saying that such prompt payment would make NUPEMCO more attracting to the stakeholders.

Professor Rasheed thanked the Universities' Vice Chancellors present and those who sent their representatives, advocating also that the shareholders and stakeholders meeting be held and told the management not to be discouraged as he believed that the body had come to stay and outlive the founders.

Chairman of NUPEMCO Board, Dr. Oladipo Fasina said that the pension company had to overcome a lot of challenges and difficulties, including recognition by the universities over a long period before its eventual registration. One of such was the tasks of convincing the Universities' Vice





Chancellors that NUPEMCO was here to stay.

It was also a huge task on the path of the VC's to convince their staff of the advantages and potentials as well as inherent benefits derivable from joining the pension company.

The Acting Managing Director of NUPEMCO, Mrs. Oluwakemi, said that the reason for the meeting was to enlighten the shareholders on what they stand to gain, by being members of NUPEMCO. She listed some of these advantages to include: creating an improved work

She assured shareholders that activities of NUPEMCO shall remain transparent, while excellence and dedication will be its watchword. She, however, noted that the pension body had proposed to have offices in; Awka, Lagos, Ibadan, Gombe, Port-Harcourt and Kano, for ease of its business.

In her words "We want to be the PFA of choice, the PFA to associate with". Reacting to the Executive Secretary's request, the management of NUPEMCO listed the names of Institutions and the amount they had invested so far. These include: University of Ilorin, N25million;

University Kano, N10million; National Open University of Nigeria, N10million; Obafemi Awolowo University, N10million and University of Uyo, N10million.

Others are NUC, N50million; ASUU, N474million; TETFund, N200million; NASU, N40million; Ahmadu Bello University, N10million; Benue State University, N10million; Michael Opara University of Agriculture, N10million and Federal University of Technology Akure, N10million.

The Vice-Chancellor of the National Open University of Nigeria (NOUN) Professor Abdalla Uba Adamu has disclosed that President Muhammadu Buhari had assented to NOUN Amendment Act which in every capacity would enable graduates to participate in the mandatory oneyear National Youth Service Corp (NYSC) Scheme and also attend the Nigerian Law School. He made the disclosure in his remarks last Wednesday during the 13th Inaugural Lecture of the University titled "That All May Eat", delivered by Distinguished Professor Okagbare.

He stated by this Presidential assent to the NOUN Amendment Act, all barriers were now eliminated which meant that the Open University was now at par with every other Universities' Act in the country.

The implication, he said, enthusiastically was that the old perception people had on NOUN that it operated on part -time basis or by correspondences was gone. He explained that right from its inception in 1983; it had never been a part-time institution or offered knowledge by correspondence. It was all a figment of the peoples' perception, he reiterated.

He pointed out that between 1983 and 2003, a new narrative entered into the educational debate in Africa and that was the Open and Distant Learning

(ODL). By 2003 people had begun to realise that ODL was different from correspondence.

According to Professor Abdalla correspondence education referred to when one sit at home

and lectures are brought to you by radio or sent to you, in this case there is no contact with the University. In ODL, he said, study centers are created, with study materials provided to the students in the centers, while the students engage with facilitators.

He said that one of NOUN's conditions for the operation to open a study centre anywhere include the existence of a facility room, where students could engage with a facilitator.

He said that by the time ODL

became part of the narrative, the Open University of Nigeria made sure that its Law Programme were amended to reflect ODL and online. With the President's

assent, it meant that the institution operated like any other University, he added.

He stressed that Law School prevented students from studying Law at NOUN because they were under the impression that NOUN was a part-time institution and their (law school) rules and regulations do not allow part-time students.

The Vice-Chancellor of NOUN said that with the changes, the school was now entering into negotiation with the authorities of Law School to know what to do and was willing to accept whatever conditions the Law School would provide.

He lamented that most of the northern states were lagging behind in ODL. He said that if one pick up the northern states with the number of students they have in 2019, one would find out that they are not up to student population in south west alone. So, the total number of students from southwest was more than the number of students from the entire northern states.

He said part of the reason was lack of awareness on what NOUN was all about but, noted that with the



He believed that by January next year NOUN would start a number of programmes that would attract a lot of people from the North.

University had been getting

more students from that region.

Professor Abdalla said that NOUN was going to establish a study centre in Niamey, Niger Republic, as they had Nigeriens, who were interested in Mass Communication, Arabic and Hausa Languages.

He also said on the issue concerning the NYSC, NOUN was trying to reach out to the Corp Management to ask them for the way forward.

The Don revealed that NOUN had so far graduated 58,000 students since the school started without these students embarking on the youth service scheme. Ordinarily, he said, these numbers would overload the system but luckily, that not all of them were qualified because of being older than 30 years.

Start On Strong ICT Foundation

– Prof. Rasheed Advises BSU

The Executive Secretary has charged the Management of the Borno State University on the need for Academic Discipline and laying a solid foundation for academic success.

Speaking during a courtesy call by the management of the university, Prof. Rasheed reminded the Vice-Chancellor and his team that as the one of the most recently founded Universities – specifically the 44th of the 48 State universities in Nigeria, they ought to start on a very strong ICT Foundation.

He said that the NUC, had noted that the university has put in place facilities sufficient of commencement of academic activities in five (5) faculties.

He urged the university to make the request to the commission for resource verification and the attendant permission to commence academic activities in the facilities. When this process is complete, the NUC concluded by the last week of September so that ab initio, the university could commence

shall then inform JAMB of the University's readiness to take on students for academic

He encouraged the university to ensure that admissions were running a stable academic calendar.

He also encouraged them to a culture of consistency which



would help in building a strong positive reputation for the university as a stable academic environment.

Prof. Rasheed noted that being a young university, the university would not have to deal with university trade unions for the first few years of their commencement and encouraged them to therefore take a dvantage of these unencumbered years to forge a strong tradition of stability, discipline and academic excellence.

He reminded the university of the enormous goodwill pledged by the State towards the university and the interventions that would come its way from the Tertiary Education Trust Fund and warned that this goodwill must not be squandered or taken for granted. He urged the management to eschew any bad habits and systems learnt from older universities in the country and only march forward with sound academic traditions, proven good strategies and systems that will ensure that they are a contemporary world class education to which many would aspire for education.

The Executive Secretary urged that strong systems must be set up for the statutory academic processes - ranging from admissions, matriculations, examinations and convocations and encouraged the University to serve its host community well and ensure a harmonious relationship between town and gown.

He however cautioned against undue political interference and advised that all stakeholders must be made aware of the guiding principles of the university so that Management would not have to deal with difficult requests from stakeholders.

The Vice-Chancellor, Professor Umar Kyari Sandabe thanked the Executive Secretary for his words of advice and his demonstrated interest in the welfare of the young university.

He informed the Executive Secretary that the Management recognize the central role of the NUC in the life of the university and had therefore made the decision to come and acquaint themselves with the commission and other relevant education parastatals with whom the university would be interacting.

He requested the support of the National Universities Commission particularly during these early days of the university's life pledging to abide by the guidelines and regulations of the Commission.

106 Bag First Class, as UNIPORT Graduates 9,452

No fewer than 106 graduands bagged first class as the University of Port Harcourt (UNIPORT) recently graduated 9, 452 students during its 32nd Convocation Ceremony. The graduands are for the combined 2016/2017 and 2017/2018 academic sessions.

The University also reaffirmed its policies of "no payment of charges, "no examination" and zero tolerance for cultism and examination malpractices.

Addressing Journalists in Port Harcourt as part of activities marking the convocation ceremony, the Vice-Chancellor, Professor Ndowa Lale said 4,681 graduates received higher degrees from the School of Graduate Studies for the two sessions, while a total of 4, 771 are for the undergraduate category with 3,205 for the 2016/2017 and 1,556 for the 2017/2018 session.


On the payment of university charges, Professor Lale stated that there was nowhere in the world where universities run on credit or are free.

He regretted that parents pay exorbitant fees for nursery, primary and post-primary education but raise eyebrows to meagre charges in the universities, yet they expect high standards.

"I have seen parents that pay

more than N2million for their children in private secondary schools, but when it comes to UNIPORT, they quarrel with the payment of N45,000. That was wickedness. Yet when you go to Ghana, more than 70 per cent of foreign students are Nigerians and they pay much higher fees in dollars.

"To make it easy, we have even asked the students to pay N22,

500 in the first semester and pay the balance in the next semester, yet they are complaining."

He also stated that even when some parents give monies to their children to pay their fees, the students use the funds for frivolities only to claim one excuse or the other.

He also noted that the university

gives students more than six months to pay the fees but they would rather wait till the last day and claim there was congestion in the banks and that was why they could not pay their fees.

"So we stand by the policy of no payment of charges, no examination' but it is not to victimise any student. We are doing our best to provide the students and lecturers the best facilities and these things cost money," he stated.

He recalled that some students took the university to court some years ago over the policy, but the students lost the legal battle.

"I am glad to report that despite the initial setback, management of the university recently floored these misguided students in their own case against us.

"Unfortunately, these students have merely wasted their time and delayed their career progression on the misguided advice of their 'godfathers' and 'patron saints' who have now abandoned them to their fate. It is my hope that students will confine themselves to the main reason they are here and play by the rules."

He however said the university would pardon the affected students if they come back to complete their programmes and abide by the rules of the institution.





UNIOSUN Partners African Varsities on Data Usage for Research Reproduction

Osun State University (UniOsun), in partnership with the Association of African Universities (AAU), has initiated a research model on how African universities can use 'stata' to do analysis on reproduction of research.

The initiative was discussed at the second research/training and Skills for Reproduction of Research Findings Using Stata,' held at MicCom Golf and Hotel, Ada, Osun State.

Speaking at the event, the Project Officer for AAU, Mr. Samuel Nyarko Agyapong said the workshop was aimed at training the next generation of African researchers on data analysis tools and practices to enhance the transparency and openness of research.

He explained that the focus of the workshop was to make participants gain basic understanding and skills in analysing research data in a reproducible manner.

In his remarks, the Vice-

Chancellor of UNIOSUN, Professor Labode Popoola said the most pressing problem facing the world today is the increasing complex approach to research.

He said some of the factors responsible for lack of global recognition for African research are low research quality, lack of a p p r e c i a t i o n o f d a t a manipulation, among others.

"Exchanging data and other research outputs among researchers could open up new avenue for discovery and innovation that might never have been anticipated by the original data generators. Also, access to the data underlying research findings is critical to ensure that these claims can be scrutinised and reproduced.

"Additionally, it is no longer news that most African researchers still face difficulties in publishing their research findings. Among other factors, these difficulties could be attributed to the lack of research quality, poor data, lack of appreciation of the data manipulation process and lack of research integrity.

"I believe this workshop is poised to address some of these important research challenges for improved research quality, integrity and output on the African continent.

"Osun State University is committed to high quality research and we are glad to work with the Association of African Universities in relevant capacity building," he submitted.

RE: MORATORIUM ON PART-TIME PROGRAMMES

he National Universities Commission, cognizant of the need to streamline the operations of Part Time and Sandwich programmes in Nigerian universities, had through a publication in the print media, including the Guardian and Sun Newspapers of Monday, 19th March, 2012, placed a moratorium on admission into parttime programmes in Nigerian universities. In the publication, the universities were requested to fully disclose all Part-Time and Sandwich programmes, with respect to enrolment and staffing profile, within four weeks of the publication, and to conduct in-house staff and student audit and forward same to the Commission. As a follow up to this, the Commission vide a letter dated 14 January, 2013, sent a reminder to the universities requesting those that were yet to provide information on their Part-Time and Sandwich programmes as well as affiliation arrangements to do so on or before 15 February, 2013.

GUIDELINES ON PART-TIME AND SANDWICH PROGRAMMES IN NIGERIAN UNIVERSITIES

Below are guidelines for conducting Part-time and Sandwich programmes in Nigerian universities. All universities currently operating Part-time programmes are expected to comply with the guidelines on programme by programme basis.

Consequently, universities still interested in running Part-time programmes are advised to forward fresh applications to the NUC on programme by programme basis.

This is, however, subject to the readiness of the university to comply with the following extant guidelines on part-time programmes:

- 1. The admission and graduation requirements, Staffing, Library and physical facilities requirements must be in line with the Benchmark Minimum Academic Standards (BMAS) for the various full-time academic programmes;
- 2. For a programme to be eligible to run on part-time basis, the approved full-time equivalent must be available in the university, must have earned full accreditation and must be run within approved campuses;
- 3. The enrolment into part-time programmes must not exceed 20% of total students' population in the programme;
- 4. The minimum duration of the part-time programmes must be 150% of the approved duration of the Full-Time equivalent;
- 5. Approval shall not be granted for part-time programmes in Environmental Sciences, Engineering/Technology, Law, Medicine/Medical Sciences, Pharmacy /Pharmaceutical Sciences, Dentistry; and Veterinary Science;
- 6. All admissions into part-time programmes must be through the Joint Admissions and Matriculation Board (JAMB). Part-time programmes must be run within approved campuses of universities where the human and material resources for the teaching of the programmes are domiciled, i.e. on the main campus of the university;
- 7. Part-time programmes shall be subjected to the NUC accreditation assessment upon maturity of the programme;
- 8. For any programme to be eligible for part-time mode, it must have produced two (2) sets of graduates and satisfied the Resource Verification Requirements.
- 9. Commencement of a part-time programme MUST be subject to NUC's approval. Approval of commencement of all parttime programmes must be obtained.

The National Universities Commission shall not hesitate to apply appropriate sanctions on any university which violates any of the stipulated Guidelines on Part-Time and Sandwich Programmes.
