safer, healthier, and more resilient Nigeria for all.

He said, Nigeria, like many countries around the globe, faced mounting challenges in mitigating the spread of zoonoses, which, not

only endangered human health, but also compromised food security, economic stability, and ecological balance.

He noted that despite this adversity, opportunity existed through One Health approach advocated by EPISON which offers a holistic framework for interdisciplinary cooperation, fostering synergies among health professionals,

veterinarians, environmental scientists and policy-makers.

He argued that by recognising the interconnected nature of health and embracing collaborative solutions, the nation would effectively prevent, detect, and respond to zoonotic threats, thereby safeguarding public health and promoting sustainable development.

He further stated that, as stakeholders in the pursuit of One Health, everyone has a pivotal role to play in shaping a healthier, more resilient future for Nigeria.

According to him, through knowledge exchange, innovative research, capacity building, and evidence-based advocacy, the country could collectively strengthen its preparedness and response mechanisms, enhance surveillance and monitoring systems, and promote sustainable practices that mitigate the risk of zoonotic disease transmission.

He used the platform to inform the Society that, as a Commission, the agency had been instrumental in several breakthroughs within the health sector through the instruments of accreditation and regulation of Medical and healthrelated programmes in Nigerian universities.

The essence, he stressed, was to ensure that these programmes meet minimum academic standards, for the production of high-quality healthcare professionals to effectively address the country's healthcare needs.

He also said NUC collaborates with universities to develop relevant and up-to-date curricula for healthrelated courses which ensures that medical graduates are equipped with the knowledge and skills

necessary to excel in their respective fields and adapt to evolving healthcare challenges.

While wishing the participants fruitful deliberations and meaningful exchanges during the

conference, he urged them to their discussions ensure that inspire actionable insights, foster lasting partnerships, and catalyze positive change in the nation's shared pursuit of a healthier world.

In his welcome Address, the National President of Epidemiological Society of Nigeria (EPISON), Very Rev. Professor Lawrence Ulu Ogbonnaya said epidemiologists, are always at the forefront of protecting public health in Nigeria.

He described the professional association as one that had been pivotal in advancing the field of epidemiology, promoting research, and fostering collaborations that were essential for tackling the health challenges facing the nation.

He explained that EPISON remained committed to enhancing the capacity of its members to respond effectively to the everevolving landscape of disease patterns and health concerns.

He pointed out that Lassa Fever had become endemic in Nigeria and that since 2005, the incidence had been rising steadily and claiming the lives of health workers and patients.

He raised alarm that, from the Nigeria Centre for Disease Control (NCDC) records, this year alone, the cumulative data showed a suspected case of 2122 of Lassa Fever infections, with 411already confirmed cases, Probable case 3, Death(from confirmed cases) 72, and case fatality rate of 17.5%. He said so far, 21 States of the federation and 78 LGAs have been affected.

Raising concern on the challenge of Zoonotic Diseases, Professor Ogbonnaya said it represented a significant and growing threat to human health, economic stability, and the well-being of the global communities.

He revealed that in Nigeria, the rising incidence of these diseases such as, Lassa Fever, Rabies, Ebola Virus Disease, and recently, the global pandemic of COVID-19, underscored the urgent need for a coordinated response.

He reminded the epidemiologists that Ebola Virus Disease came like a thunderbolt and caused many West African countries devastation in the years 2013 and and brought scare to 2014 Nigeria as well.

The EPSION President recalled that with the help of God, the nation mounted effective surveillance and

control measure that brought that epidemic to an end, but not without taking the lives of many health workers, especially that of the gallant heroine, Dr. Mrs. Ameyo Adedevo.

He further stated that the world was still trying to recover from the socio-economic devastation of the COVID-19, but argued that, that notwithstanding, there was certainty that other re-emerging

and emerging epidemic diseases of global impact were lurking around.

He, therefore called for robust epidemic preparedness and capacity for rapid response, both nationally and globally.

Harping on the one health approach, Professor Ogbonnaya explained that it was about a multi-disciplinary method that recognised the interconnectedness of human, animal and environmental health.

He noted that by adopting the approach, EPISON could create synergies and leverage expertise to achieve better public health outcomes.

He used the forum to appreciate everyone that made the event happen including sponsors like NUC, who gave its hall at no cost to the Society as well as the Local Organising Committee (LOC) of the conference led by Dr. Mattew Ashikeni.

A keynote Address was also

delivered by the Regional Coordinator, AFENET, Nigeria, Dr. Patrick M. Nguku.

Other goodwill messages were also delivered by the Special Guest of Honour and Honourable Minister of Health, and Social Welfare, Professor Muhammad Ali Pate, CON, represented by Dr. Godwin Itadoh; the President, International Epidemiological Association (IEA), Dr. Peju Adebiyi; World Health Organisation(WHO) representative in Nigeria, Dr. Kikiope Oluwarore; Mandate Secretary, FCT Health and Social Services Secretariat, Dr. Adedolapo A. Fasawe; Director- General NCDC, Dr. Grace Olajide represented by Director, Special Duties, Dr. John Oladole; among others.

The programme later broke into a technical session featuring two plenary sessions involving two paper presentations with three scientific papers, poster presentations as well as question

and answer sessions handled by some resource persons.

The highlight of the event was an award of excellence given to the Acting Executive Secretary, NUC, Mr. Maiyaki for his Humanitarian Efforts and Advocacy in Epidemiology.

The award was also in recognition of his exemplary leadership and role in ensuring that EPISON Conference was held without any hitches by offering the NUC Auditorium free of charge to the Society.

NUC Bemoans Funding Crisis in Nigerian Varsities,

Calls for Reforms

he Deputy Executive Secretary (DES) (Academics) of the National Universities Commission (NUC), Dr. Noel Biodun Saliu, has highlighted the urgent need for improved budgetary allocations and subventions to address the chronic underfunding of Nigerian universities.

Dr. Saliu made the call in his lecture entitled: The Nigerian University System and its Many Challenges: The Way Forward," which he delivered at the 7th Annual Registry Lecture of Elizade University, Ilara-Mokin, Ondo State.

emphasized that insufficient He funding remained a significant barrier to the effective growth and development of the nation's higher education system.

He identified adequate funding as a critical solution to the issues of poor remuneration and inadequate research and development within Nigerian universities.

The NUC Deputy Executive Secretary called on private university owners to refrain from viewing their institutions as profitmaking ventures for at least the first 10 years and urged them to employ qualified staff based on specific needs.

"There should be improved budgetary allocation and releases to public universities and improved subventions for private universities by their respective owners," he stated.

He also highlighted the necessity for private university owners to provide more infrastructural facilities and employ qualified academic staff in line with institutional requirements.

Dr. Saliu further advocated for the review and strengthening of System (NUS), including inadequate funding, infrastructural deficits, poor remuneration, insecurity, insufficient research and development, the proliferation of illegal degree-awarding institutions, and weak regulatory

NUC laws to enhance the regulation of the Nigerian University System (NUS).

He emphasized the importance of periodic curriculum reviews to reflect global realities and the expansion of access to university education through increased carrying capacity, the implementation of the Transnational Education (TNE) Policy, a n d internationalisation of university education.

In the lecture, he identified several persistent challenges within the Nigerian University

"Funding, is very crucial to the growth and development of universities. The university system requires substantial funds for the effective discharge of its core mandates of teaching, research, and community service," Dr. Saliu asserted.

He lamented that both public and private universities suffered from grossly inadequate annual budgetary allocations and releases from their respective proprietors.

According to him, studies have demonstrated that inadequate funding in Nigerian universities could be attributed to several

factors, including poor government allocations, low internally generated revenue, low school fee charges for public universities, low enrollment in private universities due to high tuition fees, institutional corruption, poor planning, insufficient research income, and minimal contributions from the private sector, non-governmental organizations (NGOs), and alumni.

"Inadequate funding leads to the under-performance of all aspects relevant to the quality delivery of university education in Nigeria, including the quality assurance activities of the regulator (NUC)," he explained.

He stressed that the annual budget for university administration remained insufficient to provide the necessary infrastructural facilities and human resources required for optimal functioning.

He also expressed concern about the appointment of inexperienced individuals to the governing councils of both private and public universities.

He stated the NUC frowned that some appointees see the positions as opportunities for financial gain rather than as a call to serve the university community.

Dr. Saliu criticized the politicization of the appointment process for the chairpersons and members of university governing councils in Nigeria.

He also pointed out that some private university owners were persisting in running their institutions as family businesses, thereby undermining the authority of the Vice Chancellor.

He said the dissolution of

governing councils by the President and Governors on the assumption of office was inimical to the growth of the university system.

He also emphasised that some Visitors to universities dictate the administrative operations of their universities without recourse to the law.

In his words: "Some Visitors to universities dictate the administrative operations of their universities without recourse to the respective University Law.

This scenario is mostly common with private and state universities. It has manifested in the dissolution of governing councils by new administrations both at the state and federal levels, and the arbitrary suspension or removal from office of Vice-Chancellors in some instances without regard to extant regulations.

"It is more worrisome in most private universities where some proprietors are unrepentant in the decision to run their universities as family businesses thereby usurping

the powers of the Vice-Chancellor.

The appointment of inexperienced persons into university councils also calls for concern as most of the appointees, particularly for the public universities see such appointments as political settlement for money making and not a call to service," he concluded.

In his remarks, former Vice-Chancellor of the Federal University of Technology, Akure (FUTA), Professor Adebisi Balogun, echoed these concerns,

calling on the Federal Government to review the appointments to university governing councils.

Professor Balogun criticised the tendency to view these appointments as political rewards rather than genuine calls to service.

The Registrar of Elizade University, Mr. Omololu Adegbenro, noted that the lecture series, which began in 2016, was aimed at creating a suitable

platform for discussing critical issues affecting the university system.

Mr Adegbenro expressed optimism that the lecture would inspire new perspectives, spark meaningful conversations, and foster connections.

The DES was accompanied to the conference by the NUC Acting Director, Inspection and Monitoring (DIM), NUC, Mrs Lydia Imoroa.

JAMB Releases Additional 3,921 Results

... Reschedules Exam for 24,535 Candidates

he Joint Admissions and Matriculation Board (JAMB) has rescheduled a total of 24,535 candidates to sit for a supplementary Unified Tertiary Matriculation Examination (UTME) holding on Saturday, June 22, 2024.

The Board has also cleared and released 3.921 additional 2024 UTME results. This release brings the total results released by the Board to 1,883,350.

Public Communication Advisor of JAMB, Dr. Fabian Benjamin conveyed this in a statement made available to newsmen last Sunday in Abuja.

He, however, said the remaining 322 candidates have been migrated to the category of candidates under examination misconduct as a prima-facie case had clearly been established that those who had registered were not those who appeared for the examination.

He revealed that the number of examination misconduct had consequently been increased by 322 to 431.

The Board had also yielded to pressure to extend the period for the 2024 Direct Entry (DE) registration, noting that it had decided to bring the DE registration to a close on Monday, 17th June, 2024.

Dr. Benjamin disclosed in the statement that the Board had painstakingly analysed the process and conduct of the 2024 UTME in some centres where

Kwara State University (KWASU), and about 20,550 UTME candidates whose results were up till now under investigation.

there were strong proofs of substantial non-compliance with the Board's standards.

"Consequently, 24,535 candidates have been rescheduled to retake the examination in their chosen Examination Towns on Saturday, June 22, 2024," he said.

According to him, the supplementary examination was scheduled for the candidates from Kwara State College of Arabic and Islamic Legal Studies (CAILS) and the

Also to take the supplementary examination were 2,702 candidates whose fingers could not be verified and have been given the benefit of doubt to sit the 2024 UTME.

The statement read in part: "The Board having yielded in the last one month to the request and pleas of many stakeholders and authorities for the extension of the period for the 2024 Direct Entry (DE) registration has decided to bring the DE registration to a close on Monday, 17th June, 2024.

In order to facilitate the wrap-up of the registration, the DE registration points have been expanded beyond the Professional Registration Centres (PRCs) owned by JAMB in the following states where there is an upsurge of prospective DE candidates:

"Lagos State: (a) JAMB PRC, No 11, Ojora Road, Ikoyi Lagos; JAMB PRC, No 35-37, Isheri Road, Ogba, Ikeja Lagos.

(c) ETC Nig. Ltd, 229, JKK House Ikorodu, Road, Ilupeju.

"Oyo State: JAMB PTC, JAMB Zonal Office, Quarters 845, Agodi G.R.A, Ibadan, Oyo State; Federal College of Education (FCE) Special, CBT Centre, Oyo; JAMB PTC, Igboho.

"Kwara State: JAMB PTC, National Headquarters Annex, After Oyun Bridge, Old Jebba Road, Ilorin, Kwara State;

University of Ilorin CBT Centre, Mini Campus.

"Osun State: JAMB PTC, behind Technical College WAEC Road, Alekuwodo, Osogbo, Osun State:

(b)JAMB PTC, Block Y (Commercial) OSPDC, Oroki Estate, Service Area, Ilobu Road, Osogbo, Osun State; JAMB PTC, Gbongon.

It is our belief that all eligible candidates would take advantage of this opportunity to register as no further extension would be entertained. The previously announced criteria for DE registration remain unchanged.

"Also, having held high-stake meetings with the principal officers of the Kwara State College of Arabic and Islamic Legal Studies (CAILS) and the Kwara State University (KWASU), on the CAILS-KWASU Diploma programme, the Board has agreed to conduct a special registration exercise for the 3,633 prospective candidates, who did not participate in the 2024 UTME based on the assumption that they would be accommodated in the 2024 DE exercise.

"These candidates are, therefore, to register at any of the approved CBT centres in Kwara, Oyo or Osun State within the next one week (ending on Monday, 10th June 2024.) to register for the UTME.

"469 others among this category of UTME candidates who had already taken the 2024 UTME need not retake the examination. The one they have already taken suffices.

"This concession is to ensure that, while standards are being maintained, efforts are in place to support and promote the aspirations of qualified and willing candidates even if it requires bending over backwards.

Therefore, concerned candidates were urged to check their results from Saturday, 1st June 2024 by sending RESULT to 55019 or 66019 to ascertain their status as those cleared would have their results while those rescheduled would be told that they had been rescheduled.

"The rescheduled candidates are to print their supplementary Examination Notification Slip from Tuesday, 4th June 2024 to ascertain their designated examination centres.

"The rescheduled examination, which is taking place on Saturday, 22nd June 2024, two weeks from now, is to give affected candidates adequate time to prepare for the exercise.

"This notice does not concern candidates whose results have been released.

"Candidates with prima facie case (s) of examination misconduct, would be further interrogated to establish their culpability after which appropriate measures would be taken on them and announced," he stated.

NOUN Students Ineligible for Student loan- NELFUND

he management of the Nigerian Education Loan Fund (NELFUND) has clarified reasons students of the National Open University of Nigeria (NOUN) were not eligible for the loan facility put in place by the administration of the President and Commander-in-Chief, Armed Forces, Federal Republic of Nigeria, Bola Ahmed Tinubu, GCFR.

The Managing Director/Chief Executive Officer of the Fund, Mr. Akintunde Sawyerr, who stated this while addressing newsmen in Abuja explained that it was due to their inability to possess the Joint Admissions and Matriculation Board (JAMB) Number- one of the major requirements.

This clarification mean that although NOUN was listed as the 29th school among the 126 federal higher institutions to benefit from the scheme on the NELFUND website, they, however, would not be among the 1.2million beneficiaries in the first phase of the project.

The MD also revealed that 60,000 students had registered for the facility in one week, out of which 30,000, representing 50 per cent of the figure, successfully applied.

He said the agency had strict criteria and guidelines, and would not bend the rules for any institution or individual, no matter how highly placed.

According to him, the Fund would ensure due diligence, "protect taxpayers' money and safeguard the

scheme from frivolously handing out money without accountability

Mr. Sawyerr said: "We have strict criteria and guidelines around how people can access this loan opportunity.

The disbursed loan would be paid directly to the institutions where the applicant's admission was domiciled to avoid diversion, while repayment of 10 per cent of

All of them are non-negotiable. JAMB (number) is nonnegotiable using this application process.

Unfortunately, if an applicant hasn't got a JAMB number, and hasn't gone through the JAMB application process, it is going to be impossible to grant that individual a loan at this stage.

It would be recalled that the President Bola Ahmed Tinubuled government had set up the loan fund to support indigent Nigerians in their higher education pursuit, while they pay back in instalments, two years, after completing their National Youth Service Corp (NYSC)

the loan would also be done by the employer of any beneficiary at source.

The repayment was made as flexible as possible as the Fund was not willing to criminalise beneficiaries who defaulted.

Meanwhile, the expected sources of NELF funding include; one per cent of all profits accruing to them Federal Government from oil and other minerals, one per cent of taxes, levies and duties accruing from the Federal Inland Revenue Service (FIRS), Nigeria Immigration Service (NIS), Nigerian Custom Service (NCS), Education Bonds and Education Endowment Fund schemes.

RE: END OF TENURE OF SOME VICE-CHANCELLORS OF FEDERAL UNIVERSITIES

I write, further to previous communication Ref. No. NUC/ES/138/Vol. 65/88 and dated 27 May 2024, to convey the directive of the Federal Ministry of Education, vide its letter Ref. RE: ABOUT 100 FAKE PROFESSORS JUST UNCOVERED IN NIGERIAN UNIVERSITIES – NUC A REBUTTAL

The attention of the National Universities Commission (NUC) has been drawn to news items, circulating on the social media, some national dailies and television stations, to the effect that the Commission has just "discovered over 100 fake Professors in Nigerian Universities". The NUC wishes to deny these media reports categorically and unequivocally. They are fake, untrue and a figment of the imagination of the author(s), all happening at an unsuitable time, when the nation is awaiting the outcome of the investigation into the fake certificate saga from universities in some neighbouring countries. The Commission therefore finds this development as unfair to all stakeholders.

Specifically, the fake news items have been circulating in two forms – (i) as a link to a 2019 online news item; and (ii) as a separate list of names of the alleged fake Professors in various Nigerian Universities, which was not the case. We consider these unfounded publications as ill-conceived and a ploy by unscrupulous persons to create in plausible a tone, disquiet, panic and provoking outcries at both the national and international levels.

For the avoidance of doubt, the Commission can confirm that it initiated in 2019 a laudable project, with the intent of compiling and publishing a list of full Professors in the Nigerian Universities System (NUS) through the use of an online portal to collate the requisite data. During the exercise, the NUC found anomalies, such as Associate Professors being listed as full Professors. It is essential to also state clearly that the Commission as a responsible Federal Government Agency, does not engage in half-baked exercises capable of tarnishing the image of Nigeria and the NUS. That was why the Commission deemed it necessary to share the collated data with the Nigerian Universities for the purpose of authentication by the competent authourities as to who qualifies to be a full professor. Based on the verified data, the Commission then in a landmark accomplishment, first published the list of full Professors who participated in the exercise in 2019. It was understood that this

would be succeeded by a continuous process of updating the list of full Professors. It is important to state at this point that all the issues pertaining to the 2019 verification of full Professors in Nigerian Universities were concluded in 2019. Since then, the Commission has entrenched a more reliable system of generating the list of full Professors in the NUS. The Commission is also conscious of the fact that some of the academics not captured in the 2019 exercise may now have matured and progressed to become full Professors; this being the reason why it continuously updates the list of full Professors in the NUS.

The National Universities Commission questions the rationale behind recycling this stale 2019 news of an activity it initiated, conducted and laid to rest in the same year. The purpose and objective of resurrecting in 2024 (more than 4 years later) this-nolonger-fresh news, is clearly intended to generate unnecessary controversy at an unsuitable time, whilst lacing it with a false list of fake Professors.

The National Universities Commission owes it a solemn duty to protect and guard the integrity of the many hardworking and committed academics in the NUS, who have earned national and international respect and recognition. Therefore, the Commission has been saddled with the vital and strategic responsibility by its enabling laws, to uphold the sanctity of quality in all aspects of our University Education delivery.

The Commission wishes to use this medium to advise Government officials at all levels, members of the NUS, the international community, and the public, to please disregard these items of fake and stale news which have long been laid to rest in 2019. Press Release SUSPENSION OF EVALUATION AND ACCREDITATION OF DEGREE CERTIFICATES FROM THE BENIN AND TOGO REPUBLICS.

The attention of the Federal Ministry of Education has been drawn to the commendable work of investigative journalism that led to the publication by the Daily Nigerian Newspaper dated 30th December 2023 titled "UNDERCOVER: How DAILY NIGERIAN reporter bagged Cotonou varsity degree in 6 weeks, participated in NYSC scheme". This was also carried in various social media.

- 2. This report lends credence to suspicions that some Nigerians deploy nefarious means and unconscionable methods to get a Degree with the end objective of getting graduate job opportunities for which they are not qualified.
- The Federal Ministry of Education vehemently decries such acts and with effect from 2nd January 2024 is suspending evaluation and accreditation of degree certificates from Benin and Togo Republics pending the outcome of an investigation that would involve the Ministry of Foreign Affairs of Nigeria and the two countries, the ministries responsible for Education in the two countries as well the Department of State Security Services (DSSS), and the National Youths Service Corps (NYSC). The Ministry therefore wish to call on the General Public to support its efforts, show understanding and provide useful information that will assist the Committee in finding lasting solutions in order to prevent further occurrence.
- The Ministry has also commenced internal administrative processes to determine the culpability or otherwise of her staff for which applicable Public Service Rules would be applied.

- The issue of degree mills institutions, i.e institutions that exist on 5. paper or operate in clandestine manner outside the control of regulators is a global problem that all countries grapple with. FME has been contending with the problem including illegal institutions located abroad or at home preying on unsuspecting, innocent Nigerians and some desperate Nigerians who deliberately patronize such outlets. Periodically, warnings have been issued by the Ministry and NUC against the resort to such institutions and in some instances, reports made to security agencies to clamp down on the perpetrators. The ministry will continue to review its strategy to plug any loopholes, processes and procedures and deal decisively with any conniving officials.
- The Ministry had always adopted the global standard for evaluation 6. and accreditation of certificates of all forms which relies on receipt of the list of accredited courses and schools in all countries of the World.
- The Ministry wishes to assure Nigerians and the general public that, it is already putting in place mechanisms to sanitise the education sector, 7. including dissuading the quest for degree certificates (locally or from foreign countries) through a re-invigorated focus on inclusivity: reliance on all skill sets as directed by President Bola Ahmed Tinubu GCFR.
- The Federal Ministry of Education is committed to collaborating with stakeholders, including civil society organizations, to consistently enhance the Nigerian education system and we value the public's understanding and patience as we strive to address these issues.
- The Federal Ministry of Education wishes all Nigerians a happy new 9. year. A year in which we would all work together to strengthen our education sector.
