FG Postpones Inauguration of Varsities, Polys, COEs Governing Councils

he Federal Government has announced the postponement of the inauguration and retreat for Pro-Chancellors, Chairmen and members of Governing Councils of federal tertiary institutions earlier scheduled for Thursday, May 30 and Friday, May 31, 2024. This was contained in a statement released on Sunday, signed by the Ministry's Director of Press, Mrs. Folasade Biriowo.

Mrs. Biriowo said, the postponement was to ensure a comprehensive review of the list as directed by the Presidency.

"This is as a result of the presidential directive, as conveyed by the State House press release dated May 23, 2024 for a comprehensive review of the membership of the governing councils of federal tertiary institutions in Nigeria.

"We regret any inconvenience this may cause.

"Further updates will be

communicated in due course," the statement by Mrs. Biriowo reads.

The President's Special Adviser on Information and Strategy, Mr. Bayo Onanuga, announced in a



with discrepancies such as some states receiving only one nomination while others had multiple appointees.

Previously, President Tinubu had sanctioned the appointment of 555 individuals to serve as Pro-Chancellors/Chairmen and members of the Governing Boards for 111 federal tertiary institutions comprising universities, polytechnics, and colleges of education, based on a list compiled by the Federal Ministry of Education (FME).

The directive for a review followed significant public backlash, including protests from the Academic Staff Union of Universities and the Academic Staff Union of Polytechnics.

FG Directs Outgoing VCs to Appoint Deputies as Acting Vice-Chancellors

he Federal Government has directed the outgoing Vice-Chancellors (VCs) in federal universities to nominate their deputies to temporarily serve as Acting Vice-Chancellors.

This was conveyed by the National Universities Commission (NUC) in a letter to the outgoing Vice-Chancellors, which was dated May 28, 2024.

The letter signed by the Acting Executive Secretary of the NUC, Mr. Chris J. Maiyaki, said the move was prompted by a directive from the Federal Ministry of

Education (FME), which duly notified the Commission on the end of tenure of some Vice-Chancellors.

While saying the appointment of the Acting Vice-Chancellors should be done through the recommendations of the Universities' Senates, the NUC said the soon-to-be inaugurated Governing Councils of the Universities would appoint Acting Vice- Chancellors after their inauguration.

A copy of the letter reads in full: "I write, further to previous communication Ref. No. NUC/ES/138/Vol. 65/88 and dated 27th May 2024, to convey the directive of the Federal

Ministry of Education, vide its letter Ref. FME/TE/C /130/T6/458 and dated 28th May 2024 (copy attached), to the effect that the Vice- Chancellors of the Federal Universities, who are rounding up their tenures are to nominate, through the recommendation of their Senates, a Deputy Vice-Chancellor that will oversee the office of the Vice-Chancellor in a temporary capacity.

"The Governing Councils, after their inauguration, will appoint Acting Vice-Chancellors for a period not less than 6 months, during which they will commence the process of appointing the substantive ViceChancellors.

This circular takes pre-eminence over our earlier communication on the same subject. Please, accept the assurances of my highest considerations always," the letter reads.

It would be recalled that in matter of days the tenures of the Vice-Chancellors of federal universities, including those of Nnamdi Azikiwe University (NAU) Awka, Professor Charles Esimene; University of Nigeria, Nsukka (UNN), Professor Charles Igwe and University of Abuja (UNIABUJA), Professor Abdallah N'Állah, among others, would soon elapse.

Acting ES Receives Delegation from German Parliament

he Acting Executive Secretary, National Universities Commission (NUC), Mr. Chris J Maiyaki, last Tuesday received in audience a delegation from the German Parliament led by the Chairman, Committee for Education, Research and Technology Assessment, His Excellency, Mr Kai Gehring, in his office.

The purpose of the visit was to conduct a selection interview for eligible Nigerian students for the International Parliamentary Scholarship (IPS) and to hold international sessions about the programme at various universities.

In his remarks, the German

Parliamentarian said the IPS programme was aimed at providing young individuals from different countries with the opportunity to participate in an intern-ship at the German Parliament and learn about the German political system.

Harping on the status of Germany in the comity of nation, he said, his country had been a trail blazer in the aspect of skilled labour, technology development and entrepreneurship.

He added that Germany had done well for its citizens and currently served as the engine room for Europe's economy.

He said it was fascinating to hear of the wide range of achievements recorded in the Nigerian University System (NUS), describing it as an honour to be in Nigeria, as both countries have rich things to share in common.

Explaining further, Mr. Gehring stated that Nigeria remained the economically most strongest and vibrant country in Africa while

Germany too was the strongest in the Europe.

Mr. Gehring said the Germans also face similar challenges in the areas of skilled labour, climate change, research, and health research. He stated that the only difference between the two countries is that Germany is democratically older than Nigeria.

He said, gender equality and internationalization were some issues the country had been dealing with.

While further drawing comparisons, Mr. Gehring stressed that Nigeria comprised of 36 states, while Germany had 60, highlighting that one of the milestones in German educational sector was the nation's investment of 35billion Euros in student placements.

He said, Germany and Nigeria had a total of 32 university collaborations with over 4,000 Nigerian students studying in

Germany, while the services offered to international students were free and the support for international programmes were also recently increased.

Mr. Gehring that the exchange between both countries should be intensified in the areas of skilled labour, science, research, and health research.

He said the programme has been designed to facilitate collaborations, and addresses common challenges between countries.

He said, for eligibility to become one of the selected beneficiaries, students needed a degree and should be below 30yrs, as well as ability to speak and write German.

He informed the Acting Executive Secretary that Nigeria was top among the countries selected for the programme this year and urged the NUC not to hesitate to share advice and information on any university student suitable for the programme.

Responding, Mr Maiyaki, who gave a brief overview of the evolution of university education in Nigeria, noted that the country's journey started with the University of Ibadan (UI), then as a University College, London established in 1948, with others subsequently coming on board, and today, with a total of 273 universities, comprising 62 Federal, 63 state and 148 private universities.

He said the yearning for university education had continued to increase with a yearly enrolment of 2million applicants, while the country could only accommodate about 500,000 to 700,000 students yearly.

The Acting Executive Secretary told the delegation that the NUC was empowered to establish private universities, lay down minimum Academic Standards. Pointing out that for any private university to be licensed it must go through a 14-step process.

He informed the visitors that their visit was timely, just at the time of widespread call for

repositioning of Nigerian universities and increase of access to university education, that led the Commission to the launch of the Transnational Education (TNE) guidelines, as well as the production of a new curriculum for Nigerian University System (NUS) to meet evolving global trends, through a team of experts and stakeholders of the academia assembled together which was supervised by the Deputy Executive Secretary (DES) Dr. Noel Biodun Academics. Saliu.

Mr. Mayaki thanked Mr. Gehring for his very elaborate speech that dwelt on salient and topical issues that bothered on research, climate change, skilled labour education.

He acknowledged that the budgeting of 35billion Euros on education alone by the German Government showed its level of commitment to the sector, stating that Nigeria had a lot to learn and tap from Germany.

He said, Nigeria has a programme geared towards enhancing gender equality, as many women were in higher education system, explaining that contribution of women was very pivotal in the country's development.

He informed the team that Nigeria had about 20 research institutes and that the NUC had the mandate to guide the delegation on its decision-making to ensure the programme got to the appropriate constituents.

The NUC scribe asserted that the Commission had remained a very

veritable gateway of channelling scholarship schemes, recalling that it served as the Secretariat of the past Presidential Special Scholarship Scheme during the administration of President Goodluck Ebele Jonathan, GCFR.

He noted that Germany had invested adequately in its manpower, while functioning as a welfare state and thanked the German government for the scholarship schemes which Nigerians had already benefited, but pleaded for more opportunities for the teeming Nigerian youths.

In a vote of thanks, the DES, Academics, Dr. Noel Saliu appreciated the delegation for the visit and wished for more fruitful collaborations between the two countries in the coming vears.

Ex-UNILAG VC Laments High Rate of Out-of School Children in Nigeria

Visiting Professor at the National Universities Commission (NUC) and immediate past Vice-Chancellor, University of Lagos (UNILAG), Professor Oluwatoyin Ogundipe last week decried the high rate of out-of-school children and the gap disparities in the education system in the country.

According to UNICEF, about 10.5 million children are currently out-of-school in Nigeria even though primary education remained officially free and compulsory.

Professor Ogundipe, whose keynote address dwelt on "Education: A Vision For The Future," at the 60th birthday Colloquium, held in honour of the 9th Vice-Chancellor, Lagos State University (LASU), Professor Ibiyemi Olatunji-Bello, said some drastic measures must be taken to return the children back to school.

He remarked that the gap refers to the disparities in educational outcomes and access to opportunities that exist among different groups of students.

He stated, "A critical challenge to education in Nigeria is the high number of children not attending school". At the primary level, the situation is particularly disturbing as the number of out of school children by geographical regions shows North-West at 3,490,670; North-East 2,001,038; South-West 1,451,739; Northdevelopment need to be squarely addressed.

Professor Ogundipe, however, pointed out that education should

Central 1,329,112; South-South, 1,208,182 and South-East 713,176.

"Seven states in the Northern Nigeria (Bauchi, Borno, Gombe, Kebbi, Yobe, and Zamfara) have out-of-school rates exceeding 50 percent. This translates to more than half of primary school-aged children in these states lacking access to any formal education."

He asserted that the above statistics showed that the growth and all-round societal

be reshaped globally across various demographics, including populations, gender, race and religion.

"Additionally, we must work towards realising the national goals of education as articulated in our National Policy of Education (NPE).

"Education in Nigeria has emancipated from the structure of service to freedom of educational opportunity for many. The Sustainable Development Goal 4 intends to achieve quality education for all

by the year 2030.

He however, lauded LASU's VC, Professor Olatunji-Bello for the infrastructure development seen all around the institution, as it also ranked among one of the best universities in the country and West Africa.

In her remarks, the Vice-Chancellor of LASU, Professor Ibiyemi Olatunji-Bello expressed enthusiasm about advancement in the present and future with the deployment of Robotics and Artificial Intelligence (AI)



RE: ABOUT 100 FAKE PROFESSORS JUST UNCOVERED IN NIGERIAN UNIVERSITIES – NUC A REBUTTAL

The attention of the National Universities Commission (NUC) has been drawn to news items, circulating on the social media, some national dailies and television stations, to the effect that the Commission has just "discovered over 100 fake Professors in Nigerian Universities". The NUC wishes to deny these media reports categorically and unequivocally. They are fake, untrue and a figment of the imagination of the author(s), all happening at an unsuitable time, when the nation is awaiting the outcome of the investigation into the fake certificate saga from universities in some neighbouring countries. The Commission therefore finds this development as unfair to all stakeholders.

Specifically, the fake news items have been circulating in two forms – (i) as a link to a 2019 online news item; and (ii) as a separate list of names of the alleged fake Professors in various Nigerian Universities, which was not the case. We consider these unfounded publications as ill-conceived and a ploy by unscrupulous persons to create in plausible a tone, disquiet, panic and provoking outcries at both the national and international levels.

For the avoidance of doubt, the Commission can confirm that it initiated in 2019 a laudable project, with the intent of compiling and publishing a list of full Professors in the Nigerian Universities System (NUS) through the use of an online portal to collate the requisite data. During the exercise, the NUC found anomalies, such as Associate Professors being listed as full Professors. It is essential to also state clearly that the Commission as a responsible Federal Government Agency, does not engage in half-baked exercises capable of tarnishing the image of Nigeria and the NUS. That was why the Commission deemed it necessary to share the collated data with the Nigerian Universities for the purpose of authentication by the competent authourities as to who qualifies to be a full professor. Based on the verified data, the Commission then in a landmark accomplishment, first published the list of full Professors who participated in the exercise in 2019. It was understood that this

would be succeeded by a continuous process of updating the list of full Professors. It is important to state at this point that all the issues pertaining to the 2019 verification of full Professors in Nigerian Universities were concluded in 2019. Since then, the Commission has entrenched a more reliable system of generating the list of full Professors in the NUS. The Commission is also conscious of the fact that some of the academics not captured in the 2019 exercise may now have matured and progressed to become full Professors; this being the reason why it continuously updates the list of full Professors in the NUS.

The National Universities Commission questions the rationale behind recycling this stale 2019 news of an activity it initiated, conducted and laid to rest in the same year. The purpose and objective of resurrecting in 2024 (more than 4 years later) this-nolonger-fresh news, is clearly intended to generate unnecessary controversy at an unsuitable time, whilst lacing it with a false list of fake Professors.

The National Universities Commission owes it a solemn duty to protect and guard the integrity of the many hardworking and committed academics in the NUS, who have earned national and international respect and recognition. Therefore, the Commission has been saddled with the vital and strategic responsibility by its enabling laws, to uphold the sanctity of quality in all aspects of our University Education delivery.

The Commission wishes to use this medium to advise Government officials at all levels, members of the NUS, the international community, and the public, to please disregard these items of fake and stale news which have long been laid to rest in 2019. Press Release SUSPENSION OF EVALUATION AND ACCREDITATION OF DEGREE CERTIFICATES FROM THE BENIN AND TOGO REPUBLICS.

The attention of the Federal Ministry of Education has been drawn to the commendable work of investigative journalism that led to the publication by the Daily Nigerian Newspaper dated 30th December 2023 titled "UNDERCOVER: How DAILY NIGERIAN reporter bagged Cotonou varsity degree in 6 weeks, participated in NYSC scheme". This was also carried in various social media.

- 2. This report lends credence to suspicions that some Nigerians deploy nefarious means and unconscionable methods to get a Degree with the end objective of getting graduate job opportunities for which they are not qualified.
- The Federal Ministry of Education vehemently decries such acts and with effect from 2nd January 2024 is suspending evaluation and accreditation of degree certificates from Benin and Togo Republics pending the outcome of an investigation that would involve the Ministry of Foreign Affairs of Nigeria and the two countries, the ministries responsible for Education in the two countries as well the Department of State Security Services (DSSS), and the National Youths Service Corps (NYSC). The Ministry therefore wish to call on the General Public to support its efforts, show understanding and provide useful information that will assist the Committee in finding lasting solutions in order to prevent further occurrence.
- The Ministry has also commenced internal administrative processes to determine the culpability or otherwise of her staff for which applicable Public Service Rules would be applied.

- The issue of degree mills institutions, i.e institutions that exist on 5. paper or operate in clandestine manner outside the control of regulators is a global problem that all countries grapple with. FME has been contending with the problem including illegal institutions located abroad or at home preying on unsuspecting, innocent Nigerians and some desperate Nigerians who deliberately patronize such outlets. Periodically, warnings have been issued by the Ministry and NUC against the resort to such institutions and in some instances, reports made to security agencies to clamp down on the perpetrators. The ministry will continue to review its strategy to plug any loopholes, processes and procedures and deal decisively with any conniving officials.
- The Ministry had always adopted the global standard for evaluation 6. and accreditation of certificates of all forms which relies on receipt of the list of accredited courses and schools in all countries of the World.
- The Ministry wishes to assure Nigerians and the general public that, it is already putting in place mechanisms to sanitise the education sector, 7. including dissuading the quest for degree certificates (locally or from foreign countries) through a re-invigorated focus on inclusivity: reliance on all skill sets as directed by President Bola Ahmed Tinubu GCFR.
- The Federal Ministry of Education is committed to collaborating with stakeholders, including civil society organizations, to consistently enhance the Nigerian education system and we value the public's understanding and patience as we strive to address these issues.
- The Federal Ministry of Education wishes all Nigerians a happy new 9. year. A year in which we would all work together to strengthen our education sector.
