According to report circulated to news media, the Council has instructed the Secretary to the Government of the Federation (SGF) to expedite the implementation of this decision made several months ago.

This move aims to address a longstanding grievance of the Academic Staff Union of Universities (ASUU), which has consistently opposed the use of IPPIS for ratified the approval for the establishment of a new National University of Science and Technology (NAUST) in Abuja.

This decision follows an initial approval granted by former President Muhammadu Buhari on May 28, 2023, during the final days of his administration.

The new university is set to be a pioneering institution, marking

the continent's capacity in these critical fields.

Meanwhile, the move to exempt universities from IPPIS and the creation of the new university signal significant steps towards resolving long-standing issues within Nigeria's higher education system and advancing scientific and technological education in the region.

JAMB Pegs Cut-off mark at 140 for Varsities, 100 for **Polytechnics**, Others

he Joint Admissions and Matriculation Board, JAMB, has approved 140 as the cut-off mark for 2024 admission into the nation's universities and 100 for Polytechnics and Colleges of Education (COEs), respectively.

The National Minimum Tolerable UTME Score (NTMUS). popularly known as the cut-off mark, for 2024 admission into tertiary institutions was arrived at last Thursday during the 2024 Annual Policy Meeting on admissions, which was held at the National Judicial Institute (NJI) Headquarters, in Jabi, Abuja.

The meeting was held following the successful conduct of the 2024 Unified Tertiary Matriculation Examination (UTME), where a total of 1,989,668 registered candidates sat for this year's UTME.

Out of the 1,989,668 registered candidates, 80,810 were absent, while a total of 1,908,858 sat for the UTME within six days of the examination.

The Policy Meeting was Chaired by the Honourable Minister of Education (HME), Professor Tahir Mamman, SAN, OON, which decided the benchmark following recommendations by the heads of institutions.

The Registrar and Chief Executive Office of JAMB, Professor Is-haq Oloyede, who announced the

cutoff marks, explained that individual institutions were at liberty to raise their minimum benchmark approved at the policy meeting but could not go below what was approved for various institutions.

Meanwhile, after the protest that greeted his decision to benchmark entry year into tertiary institutions in the country to 18 years, the Honourable Minister of Education, Professor Mamman has rescinded the decision.

He said his decision that only candidates who have clocked 18 vears be offered admissions now takes effect from 2025.

To this effect, the Minister said heads of tertiary institutions could be allowed to admit candidates who are 16 years of

passed the Unified Tertiary Matriculation Examination, UTME, and were awaiting admission.

Leading the motion, Vice Chancellor of Elizade University Professor Kayode Thadius Ijiadunola who got massive support from other Heads, Registrars, and Admission Officers participating in the Policy Meeting, proposed 16 as the minimum age requirement for admission into tertiary institutions.

He said, "What happens to those who have written this year's

exams and passed their exams? We reject 18 years as the minimum age requirement and are proposing 16 years."

While the hall erupted in support of 16 years as a minimum requirement, the Registrar of JAMB, Professor Is-haq Oloyede, also asked where parents and candidates were rushing to.

Professor Oloyede said: "The only point is they have taken examinations and at that time they were not told or aware and therefore if we want to enforce it, it should be from subsequent years."

The Minister in response had said, "I can work with that but I want to remind you of one thing, even that argument cannot stand if we want to go by the law which states 6-3-3-4 as our system of education.

"It won't stand, but for practical reasons, for this year, I will allow it to stand." Reiterating the Minister's decision amidst a resounding applause, Professor Oloyede added, "We thank the Minister for conceding but from next year we will enforce it."

Earlier, the Minister while delivering his address as chairman of the 2024 Joint Admissions Matriculation Board's (JAMB) Policy Meeting on Education called for enforcement of 18 years as the new minimum admission age for admission into tertiary institutions in the country.

Immediately after the Minister of Education, Professor Tahir M a m m a n m a d e t h e announcement, the stakeholders who turned out their members from across tertiary institutions in the country, voiced resistance which turned the session into a rowdy one.

However, normalcy was restored later with the intervention and truce called by the agreement of the JAMB Registrar and the Minister of Education to allow

UNILORIN was awarded a N500 million prize after securing 12 points in the overall category of five elements of the award.

Ahmed Bello University (ABU), Zaria emerged second best

institution with 11 points and got a cash prize of N75 million while Borno State University came third with nine points and a cash prize of N50million.

Also Kaduna Polytechnic, Kaduna emerged as best Polytechnic with 12 points and got N50 million prize at the sectoral awards while Federal College of Education, Zaria emerged as the best College of Education with 11 points and won N50 million prize in the year under review.

For Innovation Enterprise Institutions, PEFTI Film Institute, Lagos emerged winner with six points and a cash prize of N10 million.

Professor Is-haq Oloyede, said the overall award prize was increased to N750million to help winner achieve tangible result with the money.

He said any institution that emerged overall winner cannot win it again until after five years to enable the price go round.

The Registrar disclosed that this year, the Board remitted over N3.5 billion to the Federal Government and also set aside the N750 million that should be given to the winning institutions.

JAMB also received several Goodwill messages from various regulatory bodies which included those of the National Universities Commission (NUC), delivered by Mr Chris J. Maiyaki; National Board for Technical Education (NBTE), Professor Mohammed Idris Bugaje; National Commission for Colleges of Education (NCCE), Professor Paulinus Chijioke Okwelle; National Youths Service Corps (NYSC), Brigadier-General, Yusha'u Dogara Ahmed; and Chairman,

Senate Committee on Tertiary Education and TETFUND, Distinguished Senator Dandutse Muntari, among others.

IIOE Chinese Delegation Visits NUC

delegation from the International Institute of On-line Education (IIOE), China, an affiliate Institute linked with the United Nations Education, Scientific and Cultural Organisation (UNESCO), led by Professor Jiansheng Liang last Wednesday paid a courtesy visit on the Acting Executive Secretary, National Universities Commission (NUC), Mr. Chris J. Maiyaki in his office.

The International Institute of Online Education (IIOE) is a global collaborative initiative to strengthen the teacher's competency for Higher Education Institutes in developing countries and improves access to quality higher education resource.

Briefing the delegation on the evolution of university education, the Acting Executive Secretary, Mr. Maiyaki told the delegation that their visit to the NUC coincided with the period of significant expansion of the Commission's activities aimed at further increasing access to university education.

Giving insight on the emergence of NUC. he recounted that the Commission was established in 1962 as an administrative unit in the Cabinet Office and eventually became a statutory agency in 1974.

Chronicling the history of university education in Nigeria, he explained that this dated back to 1948 with the establishment of University College, Ibadan, followed by the founding of the first indigenous university, the University of Nigeria, Nsukka, in 1960; and subsequently the Ahmadu Bello University, Zaria; University of Lagos, Lagos as well as Obafemi Awolowo

and 149 Private universities.

He explained that Nigeria, currently faced significant problem of access as universities available could hardly cater for the demand

University, Ile-Ife, in 1962 and University of Benin in 1970, which marked the culmination of the first-generation universities.

He said the Mid-70's was the period that the government responded massively to the demand for tertiary education, which saw the emergence of second-generation universities and later supplemented by the establishment of private Universities in 1999.

Nigeria, the Acting Executive Secretary said, boasts of 274 Universities as at today, comprising 62 Federal, 63 States for university education.

The NUC scribe also lamented that the system witnessed an annual enrolment of over 2 million prospective individuals seeking university admission with the existing institutions only able to accommodate between 500,000 and 700,000 candidates.

Stressing on the need to address this gap, he reiterated that the NUC remained unwavering in its commitment towards facilitating the establishment of additional universities across Nigeria.

This strategic initiative, he said,

was aimed at bolstering accessibility and meeting the escalating demands for tertiary education and drew attention of his visitors to the fact that despite the presence of 149 Private universities, they could only cater for approximately 10 percent of the Nigerian university population.

Mr. Maiyaki added that the developmental trajectory of these private institutions also required granting them time to mature and expand their capacity in order to effectively contribute to the educational landscape.

On the recent achievements of NUC, he highlighted the launch of the Core Curriculum Minimum Academic Standards (CCMAS) which was a collaborative effort involving the academia and industry stakeholders.

He recounted that the process commenced in 2018 and was finally launched in 2023, highlighting the importance of the curriculum in shaping the educational landscape.

On the roles of the Commission in

the NUS, the Acting ES listed them to include: setting Minimum Academic Standards, conduct of accreditation to academic programmes, Resource Verification for new programmes, Inspection and Monitoring of universities, formulating policies, and processing the licensing of the establishment of private universities.

He informed the IIOE Chinese delegation that the NUC had recently introduced guidelines on Transnational Education (TNE), encompassing six competitive models.

While introducing the delegation, the Vice-Chancellor of Ahmadu Bello University (ABU), Zaria, Professor Kabiru Bala, whose institution is designated as the International Institute of Online Education National Centre, informed the Acting Executive Secretary that the University is hosting the Global IIOE Rotating Presidency Unit 2024, to which he assumed office this June 2024. He said the ABU in partnership with the IIOE will be hosting the one-day national dialogue, which will take place at the Communication and Digital Economy Complex, Mbora, Abuja, Entitled "National Dialogue on Consensus Framework Towards a Policy/Guidelines Roadmap for Nigerian Higher Education in the Age of Artificial Intelligence."

The event the VC said, is part of an effort to empower policy-makers, educators, learners and researchers to fully take the advantages of artificial intelligence in teaching, learning, and research.

Also speaking, the Director, IIOE Nigeria National Centre, Ahmadu Bello University, Zaria, Professor Muhammad Bashir Mu'azu, said, specifically, the objective of the national dialogue is to examine the potential benefits of incorporating AI technologies in teaching, learning, and research to improve innovation, global competitiveness and preparedness for the future

"It is to also identify challenges related to the responsible, ethical and safe use of AI and cybersecurity concerns within the higher education landscape.

He also pointed out that the ABU UNESCO IIOE national centre remained the first to domesticate the issue of teacher professional development trainings for micro certifications. He said ABU, was collaborating with the UNESCO IIOE to codevelop two courses of the teacher professional development while the University had also benefited from some smart classrooms donations since 2022 from the Institute.

Meanwhile the dilaogue will be declared open by the Honourable Minister of Education, Professor Tahir Mamman, SAN, OON, while Professor Mu'azu, will make a presentation on "AI in Higher Education: Ethical Challenges and the Need for a Governance Framework".

Speaking at the event, Professor Liang the leader of the Chinese team, who spoke through an interpreter, UNESCO-ICHEZ Consultant, Mr. Roger Yanwen Jieo said the major mission of IIOE is to Cultivate highly skilled and technically proficient talents; Foster collaboration between the TVET sector and private sectors;

RE: ABOUT 100 FAKE PROFESSORS JUST UNCOVERED IN NIGERIAN UNIVERSITIES – NUC A REBUTTAL

The attention of the National Universities Commission (NUC) has been drawn to news items, circulating on the social media, some national dailies and television stations, to the effect that the Commission has just "discovered over 100 fake Professors in Nigerian Universities". The NUC wishes to deny these media reports categorically and unequivocally. They are fake, untrue and a figment of the imagination of the author(s), all happening at an unsuitable time, when the nation is awaiting the outcome of the investigation into the fake certificate saga from universities in some neighbouring countries. The Commission therefore finds this development as unfair to all stakeholders.

Specifically, the fake news items have been circulating in two forms – (i) as a link to a 2019 online news item; and (ii) as a separate list of names of the alleged fake Professors in various Nigerian Universities, which was not the case. We consider these unfounded publications as ill-conceived and a ploy by unscrupulous persons to create in plausible a tone, disquiet, panic and provoking outcries at both the national and international levels.

For the avoidance of doubt, the Commission can confirm that it initiated in 2019 a laudable project, with the intent of compiling and publishing a list of full Professors in the Nigerian Universities System (NUS) through the use of an online portal to collate the requisite data. During the exercise, the NUC found anomalies, such as Associate Professors being listed as full Professors. It is essential to also state clearly that the Commission as a responsible Federal Government Agency, does not engage in half-baked exercises capable of tarnishing the image of Nigeria and the NUS. That was why the Commission deemed it necessary to share the collated data with the Nigerian Universities for the purpose of authentication by the competent authourities as to who qualifies to be a full professor. Based on the verified data, the Commission then in a landmark accomplishment, first published the list of full Professors who participated in the exercise in 2019. It was understood that this

would be succeeded by a continuous process of updating the list of full Professors. It is important to state at this point that all the issues pertaining to the 2019 verification of full Professors in Nigerian Universities were concluded in 2019. Since then, the Commission has entrenched a more reliable system of generating the list of full Professors in the NUS. The Commission is also conscious of the fact that some of the academics not captured in the 2019 exercise may now have matured and progressed to become full Professors; this being the reason why it continuously updates the list of full Professors in the NUS.

The National Universities Commission questions the rationale behind recycling this stale 2019 news of an activity it initiated, conducted and laid to rest in the same year. The purpose and objective of resurrecting in 2024 (more than 4 years later) this-no-longer-fresh news, is clearly intended to generate unnecessary controversy at an unsuitable time, whilst lacing it with a false list of fake Professors.

The National Universities Commission owes it a solemn duty to protect and guard the integrity of the many hardworking and committed academics in the NUS, who have earned national and international respect and recognition. Therefore, the Commission has been saddled with the vital and strategic responsibility by its enabling laws, to uphold the sanctity of quality in all aspects of our University Education delivery.

The Commission wishes to use this medium to advise Government officials at all levels, members of the NUS, the international community, and the public, to please disregard these items of fake and stale news which have long been laid to rest in 2019. Press Release <u>SUSPENSION OF EVALUATION AND ACCREDITATION OF</u> <u>DEGREE CERTIFICATES FROM THE BENIN AND TOGO</u> <u>REPUBLICS.</u>

The attention of the Federal Ministry of Education has been drawn to the commendable work of investigative journalism that led to the publication by the Daily Nigerian Newspaper dated 30th December 2023 titled "UNDERCOVER: How DAILY NIGERIAN reporter bagged Cotonou varsity degree in 6 weeks, participated in NYSC scheme". This was also carried in various social media.

 This report lends credence to suspicions that some Nigerians deploy nefarious means and unconscionable methods to get a Degree with the end objective of getting graduate job opportunities for which they are not qualified.

3. The Federal Ministry of Education vehemently decries such acts and with effect from 2nd January 2024 is suspending evaluation and accreditation of degree certificates from Benin and Togo Republics pending the outcome of an investigation that would involve the Ministry of Foreign Affairs of Nigeria and the two countries, the ministries responsible for Education in the two countries as well the Department of State Security Services (DSSS), and the National Youths Service Corps (NYSC). The Ministry therefore wish to call on the General Public to support its efforts, show understanding and provide useful information that will assist the Committee in finding lasting solutions in order to prevent further occurrence.

 The Ministry has also commenced internal administrative processes to determine the culpability or otherwise of her staff for which applicable Public Service Rules would be applied. 5. The issue of degree mills institutions, i.e institutions that exist on paper or operate in dandestine manner outside the control of regulators is a global problem that all countries grapple with. FME has been contending with the problem including illegal institutions located abroad or at home preying on unsuspecting, innocent Nigerians and some desperate Nigerians who deliberately patronize such outlets. Periodically, warnings have been issued by the Ministry and NUC against the resort to such institutions and in some instances, reports made to security agencies to clamp down on the perpetrators. The ministry will continue to review its strategy to plug any loopholes, processes and procedures and deal decisively with any conniving officials.

6. The Ministry had always adopted the global standard for evaluation and accreditation of certificates of all forms which relies on receipt of the list of accredited courses and schools in all countries of the World.

7. The Ministry wishes to assure Nigerians and the general public that, it is already putting in place mechanisms to sanitise the education sector, including dissuading the quest for degree certificates (locally or from foreign countries) through a re-invigorated focus on inclusivity: reliance on all skill sets as directed by President Bola Ahmed Tinubu GCFR.

8. The Federal Ministry of Education is committed to collaborating with stakeholders, including civil society organizations, to consistently enhance the Nigerian education system and we value the public's understanding and patience as we strive to address these issues.

9. The Federal Ministry of Education wishes all Nigerians a happy new year. A year in which we would all work together to strengthen our education sector.
